Title of Report Review of Validation Requirements for planning applications

and related consents

Purpose of Report To approve the revised list of requirements for planning

applications and related consents for consultation purposes

Recommendation: to approve the revised requirements for validating planning applications and related consents for consultation purposes.

1. Background

- 1.1 Planning applications and applications for related consents (ie listed building and conservation consent) require different levels of information and supporting documentation depending on the scale and type of development proposed. There is a national core list of requirements but each local planning authority may also set out a list of additional information and documentation required to reflect national and local policies. This is known as the 'local validation check-list' or 'local list'. Provided this list has been consulted on and is published on the local authority web site, an application is not valid if it doesn't have all the information and documentation required.

- I.3 Following consultation and discussion with all the host Authorities the South Downs National park Authority (SDNPA) adopted a single local list of validation requirements for all applications submitted for development within the South Downs National park (SDNP) from I April 2012. At the time of introducing this, the Park Authority made clear it would be subject to a review after I2 months in operation.
- In December 2012 the government published its response to a consultation on streamlining validation requirements. Of particular relevance to the SDNPA review is the move towards a reduction in the requirement for information at the validation stage. The Growth and Infrastructure Bill, which was introduced to Parliament on 18 October 2012, includes measures which will place limits on the powers of local authorities to require information with planning applications by stipulating that such requests must be genuinely related to planning and reflect the nature and scale of the development proposed. An example of the proposed measures is the reduction in the types of application where there is a requirement for a Design and Access Statement.

requirements of our local Validation List are proportionate.

As stated above and in line with our principle to learn from experience and improve, as well as adopt a proportionate approach, we are assessing the 'soundness' of the local validation list. Whilst this would appear to have been ahead of Government thinking, new legislation comes into force on 31 January 2013 which requires review of a local validation list every 2 years. If it is not the local planning authorities can no longer invalidate applications which do not meet the requirements of the local validation list.

2. The Outcome of the Review

- 2.1 The review has highlighted some issues with certain requirements, in particular
 - Landscape and Visual Impact Assessment. The need for a landscape and visual impact
 assessment for all applications has been perceived as too onerous by both applicants
 and our host authorities, notwithstanding the provision of guidance and the ability to
 submit a proxy checklist where there is likely to be no impact. This has resulted in
 delays in validation and a degree of customer dissatisfaction.
 - Planning Obligations and Parking provision, for which the need is not easily assessed at validation stage
 - The Statement of Community Involvement

These issues have been discussed with the Heads of the development management services in our partner authorities and some amendments are now proposed and some requirements are proposed to be deleted altogether. The revised requirements result in a more proportionate approach which will simplify and speed up the validation process to benefit both applicants and officers whilst still ensuring sufficient information is submitted to be able to fully assess the impact of proposals on the natural beauty, wildlife and cultural heritage of the SDNPA in accordance with the first purpose of designation.

- 2.2 In addition a separate list of validation requirements is proposed for Minerals and Waste applications as the information requirements differ to other types of development and there are specific requirements that need to be addressed.
- 2.3 The proposed revision to the original list, excluding Minerals and Waste, are set out in the table at **Appendix I** which shows the adopted requirements and the reason for change. The Minerals and Waste List is set out at **Appendix 2**. If approved the revised local list requirements would be the subject of an 8 week consultation in accordance with the SDNPA Statement of Community Involvement.
- 2.4 The local planning policy justification for the particular local validation requirement will depend on the local development plan current in the local authority area in which the application is made until the SDNPA adopts its Local Plan. As there are only 4 Minerals and Waste Authorities, the Minerals and Waste list also contains the national and local policy drivers, as well as where additional guidance can be found. As there are 11 districts with development plans at different stages of adoption it is not practical to include the policy drivers in the list of requirements for general applications in a single list but for consultation purposes it is proposed to insert the relevant policies from the local plan or core strategy within each local authority area. Links to the appropriate guidance will be inserted at this time. When the final lists are adopted the local authorities will each have their own policies inserted on their web site and a master list will be published on the SDNPA web site.

3. Consultation

- 3.1 It is proposed to consult all stakeholders who were consulted previously in respect of the SDNPA local validation lists last year including all parish councils and statutory consultees and key stakeholders including the South Downs Society, CPRE, RSPB, and National Trust.
- 3.2 The consultation would commence in March 2013. The outcome of the consultation will be reported back to the Committee in June 2013 with any further revisions considered appropriate as a result of responses received.

4. Resources

4.1 The cost of the consultation will be less than £500 for incidental expenses (postage, travel, materials etc and will come from the existing budget using existing staff time.

5. Risk management

5.1 Risk - the local list which has operating since April 2012 has resulted in validation delays.

Mitigation - the revised list is less onerous and guidance will ensure the information provided is proportionate

5.2 Risk – Despite changes the list is still too onerous.

Mitigation – The list responds to feedback over the year, and as noted in 1.6 will be subject to further review

5.3 Risk – The previous requirements for Local Landscape Validation Requirement on all applications now tailored, will result in poorer quality applications

Mitigation – As above in terms of being open to review and Link Officers can ensure applications submitted are generally of a quality suitable to be determined.

6. Human Rights, Equalities, Health and Safety
