
vii. Securities

- d) participate in any discussion or vote on the matter in which I have a disclosable pecuniary interest (unless I have received a dispensation in accordance with the Localism Act 2011).

Furthermore, I recognise that it is a breach of the Localism Act 2011 and a criminal offence, to provide information that is false or misleading and I:-

a) know that the information is false or misleading; or

b) am reckless as to whether the information is true and not misleading.
