What category does your pre-application proposal fall within?

The SDNPA pre-application service offers different levels of service depending on the nature of a proposal and its complexity. Accordingly, there are a number of proposals where it is not immediately apparent which category of the pre-application service structure the proposal would fall within.

The following guidance is intended to assist both applicants and the SDNPA is categorising pre-application enquiries. If it is still not clear what category the proposal falls within please contact your relevant planning office.
