
1. 2. For the purposes of this requirement, you or your partner have a beneficial interest if the total nominal value of the securities exceeds £25,000 or 1/100th of the total issued share capital of that body; or if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds 1/100th of the total issued share capital of that class.

3. "Securities" means any shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme (within the meaning of the Financial Services and Markets Act 2000) and any other securities of any description, other than money deposited with a building society.

Declaration

1. I recognise that it is a breach of the Localism Act 2011 and a criminal offence, if without reasonable excuse; I:-
- a) Fail to give notice to the Authority's Monitoring Officer of any disclosable pecuniary interest which I have or my partner has within 28 days of becoming a member,
 - b) Fail to disclose at a meeting of the Authority (or any committee or sub-committee of the Authority) an unregistered disclosable pecuniary interest in any matter to be considered at the meeting of which I am aware (unless the interest is "sensitive" within the meaning of the Localism Act 2011, in which case I must disclose merely the fact that I have a disclosable pecuniary interest in the matter concerned),
 - c) In the circumstances of (b) above, fail to give notice to the Authority's Monitoring Officer of the interest within 28 days of the meeting (unless the unregistered interest is the subject of a pending notification); or
 - d) Participate in any discussion or vote on the matter in which I have a disclosable pecuniary interest (unless I have received a dispensation in accordance with the Localism Act 2011).
2. Furthermore, I recognise that it is a breach of the Localism Act 2011 and a criminal offence, to provide information that is false or misleading and I –
- a) Know that the information is false or misleading; or
 - b) Am reckless as to whether the information is true and not misleading.
