**CONSULTATION FROM MONDAY 11 JUNE 2018 TO MONDAY 23 JULY 2018**

REGULATION 16 – THE NEIGHBOURHOOD PLANNING (GENERAL) REGULATIONS 2012 AND THE  
LOCALISM ACT 2011

Lewes Town Council has submitted its Neighbourhood Development Plan (NDP) for independent Examination. Lewes as the county town of East Sussex and the largest market town in the National Park is a key part of the development part of the South Downs National Park. The NDP includes planning policies on housing, including allocations for at least 220 new homes in Lewes, as well as policies on Low Cost Housing, Ecosystems Services, Heritage, the Environment, Sustainability, Design, Working & Shopping, Getting Around and Local Green Spaces. Once adopted, these policies will be used to determine planning applications locally along with the South Downs Local Plan.

Consultation on the Submission (Regulation 16) version of the Neighbourhood Plan is taking place for 6 weeks from **9:00am MONDAY 11 JUNE 2018 TO 11:59pm MONDAY 23 JULY 2018**. All representations received from this consultation will be forwarded to an independent Examiner appointed to consider the Neighbourhood Plan.
