1 Tranquility



According to the Campaign to Protect Rural England (CPRE), tranquillity is defined as 'places which are sufficiently far away from the visual or noise intrusion of development or traffic to be considered unspoilt by urban influences'




Figure D.2: Historic Landscape Character: This map defines the various historic landscape character classifications.

2.2 Indicative Landscape Character




Figure D.3: Indicative Landscape Character: This maps out the distinctive landscapes and their characteristics within the Lewes settlement boundary and beyond.

3.1 BAP Priority Areas



3.2 Biodiversity Opportunity Areas




Figure D.5: Biodiversity Opportunity Areas: This shows identifies where the greatest opportunities for habitat creation and restoration are within the plan area.

3.3 SSSI Sites




Figure D.6: Nature Conservation Sites: This shows the SSSIs, SACs as well as local wildlife sites located within the neighbourhood boundary.

3.4 Habitat Management Areas




Figure D.7: Management Areas and Habitat Designations: This shows the green infrastructure around the town, as well as key habitat designations.




Figure D.8: Historic Environment: This outlines the main conservation area, as well as scheduled monuments and listed buildings, within the settlement boundary.




Figure D.9: Historic Urban Character Areas: This shows the Historic Urban Character areas of the town as defined in the Lewes Extensive Urban Survey

5 Flooding


