Thank you for your email. In response to your requests:

- The Highways Authority (Hampshire County Council) were consulted at Pre Submission and Submission. You have a copy of their Submission response which relates entirely to the school and there is no reference to Highways matters. This is also the case with their pre submission response, which I attach, they do not make reference to highways matters. Hampshire County Council (HCC) have requested that all NDP consultations are sent to one point of contact at HCC and they circulate the consultation to all departments. I have asked HCC to confirm that they have no highways comments to make in relation to the proposed allocated sites, as soon as I get confirmation I will pass this on. I have also asked the Parish Council to forward any materials relating highways matters which they have received from Hampshire outside of the formal consultation periods, again I will forward this on if I receive anything further.
- Appeal decision for Inwood Road attached
- The SDNPA have been involved in the assessment of potential residential site allocations. This involvement includes our SHLAA assessment of the sites. This <u>link</u> will take you to our webpage where you can find the SHLAA documents which include reference to Liss sites, appendix C will give you a summary of all sites assessed by settlement and Appendix E will show you the detail relating to each assessed site. I have asked our Landscape Officer to provide me with her detailed comments in relation to landscape, which were used to form the SHLAA. I should be able to send this further information tomorrow. Our landscape officer also attended a site visit with the Neighbourhood Planning group in December 2015. A note of this meeting was prepared by the Qualifying Body, I attach that note. There will be emails conversations between Liss NDP group and the SDNPA, I expect this will amount to a great number of emails. I would imagine there will be reference to sites throughout these email conversations. I would be happy to pull some of this together but it would take a significant amount of time as I expect there will be a significant number of emails. If you would like me to do this please let me know and I can try to assess roughly how long this will take

I hope this helps and I will forward on the other materials I refer to above as soon as I receive them
