(GENERAL PERMITTED DEVELOPMENT) (ENGLAND) ORDER 2015**

DIRECTION MADE UNDER ARTICLE 4 (1)

**RELATING TO LAND AT LITTLE VICARAGE FARM (formerly known as
"Charellen") VICARAGE LANE SWANMORE SO32 2PW**

WHEREAS the South Downs National Park Authority ('the Authority') being the appropriate Local Planning Authority within the meaning of Article 4(5) of the Town and Country Planning (General Permitted Development) (England) Order 2015, is satisfied that it is expedient that development of the description set out in the First Schedule hereto should not be carried out on the land shown edged red on the attached plan more particularly described in the Second Schedule below, unless permission therefore is granted on an application made under Part III of the Town and Country Planning Act 1990 (as amended).

NOW THEREFORE the said Authority in pursuance of the powers conferred upon it by Article 4(1) of the Town and Country Planning (General Permitted Development) (England) Order 2015 hereby direct that the permission granted by Article 3 of the said Order shall not apply to development on the said land of the description set out in the First Schedule below.

THIS DIRECTION is made under article 4(1) of the said Order and, in accordance with Schedule 3, shall remain in force until 14 December 2015 (being six months from the date of this Direction) and shall then expire unless it has been confirmed by the appropriate local planning authority in accordance with Schedule 3 paragraph 2(6) before the end of the six month period.

FIRST SCHEDULE

Fences, Gates, Walls and other means of enclosure

The erection construction maintenance improvement or alteration of a gate fence wall or other means of enclosure being development comprised within Schedule 2 Part 2 Minor Operations Class A of the Order and not being development comprised in any other class

SECOND SCHEDULE

Land at Little Vicarage Farm (formerly known as "Charellen") Vicarage Lane Swanmore SO32 2PW shown edged red on the attached plan.

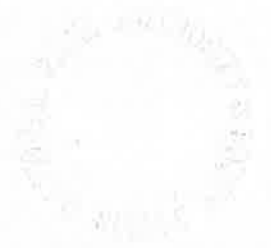

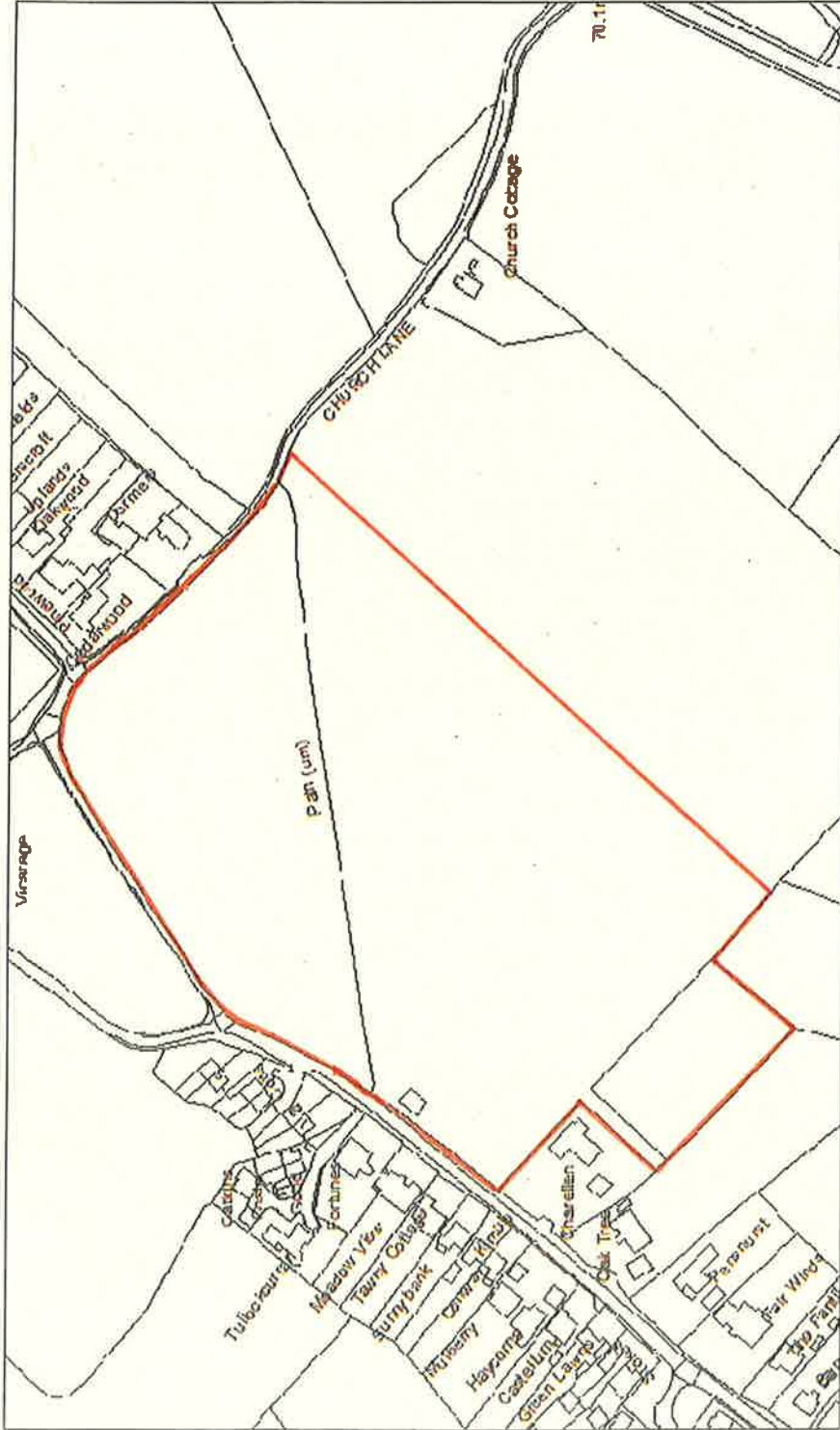
