TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1963

Direction under Article 4 relating to certain land within
the Rural District of Chanctonbury

WHEREAS the Council of the Rural District of Chanctonbury, acting for and on behalf of the West Sussex County Council, the local planning authority for the said Rural District of Chanctonbury, are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on certain land within the Rural District of Chanctonbury, namely, land comprising Ordnance Survey Parcel Nos. Part 357, Part 358, Part 359 (Sheet No. LII.13 Sussex (West) Edition of 1912) 148, 131, 129, 149, 108, 130, Part 150, 107, 105, 109, 104, 103, 152, 153, 154, 42, 41, 40, 39, 38, 30, 31, 32, 155 (Sheet No. LII.9 Sussex (West) Revision of 1937) Part 362, Part 361, Part 359, 365, 75, 85, 76, 73, 74, 72, 78, 77, 82B, 82 and 82A (Sheet No. LII.10 Sussex (West) Edition of 1910) shown coloured pink on the plan annexed hereto (hereinafter called "the said land") unless permission therefor is granted on an application in that behalf made under the Town and Country Planning General Development Order, 1963

NOW THEREFORE the said Rural District Council acting for and on behalf of the West Sussex County Council pursuant to the powers contained in Article 4 of the Town and Country Planning General Development Order, 1963, HEREBY DIRECT that the permission granted by Article 3 of the said Order shall not apply to any development on the said land of the description set out in the Schedule hereto (being development comprised within ~~Classes VI (Agricultural Buildings Works and Uses) and XXII (Use as a Caravan Site)~~ in Part I of Schedule 1 to the said Order)

SCHEDULE

~~The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture, other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings.~~

The use of land, other than a building as a caravan site in any of the circumstances specified in paragraphs 2 to 9 (inclusive) of Schedule 1 to the Caravan Sites and Control of Development Act, 1960, or in the circumstances (other than those relating to winter quarters) specified in paragraph 10 of the said Act.
