

MID SUSSEX DISTRICT COUNCIL

TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT ORDER 1977

WHEREAS the MID SUSSEX DISTRICT COUNCIL of Oaklands Oaklands Road Haywards Heath in the County of West Sussex being the appropriate Local Planning Authority within the meaning of Article 4 of the Town and Country Planning General Development Order 1977 is satisfied that it is expedient that development of the descriptions set out in the Schedule hereto should not be carried out on land forming part of Southdown Farm Lodge Lane Keymer West Sussex being the land shown edged red on the plan annexed hereto unless permission therefor is granted on application made in that behalf under the Town and Country Planning General Development Order 1977

N O W THEREFORE the said Council in pursuance of the powers conferred upon it by the said Article 4 HEREBY DIRECT that the permission granted by Article 3 of the Town and Country Planning General Development Order 1977 shall not apply to development on the said land of the descriptions set out in the Schedule hereto SAVE that this Direction shall not apply to the boundaries of the land between the points marked A and B on the plan attached hereto

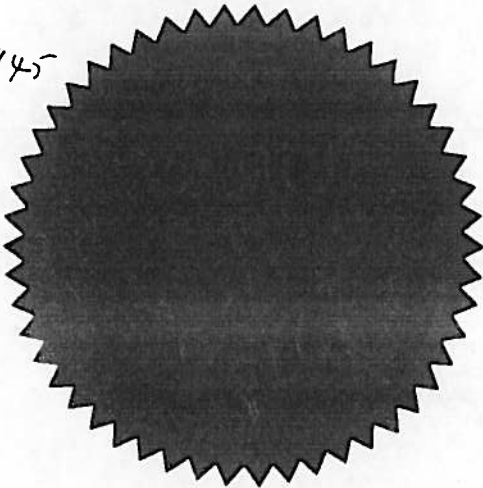
This Direction may be cited as the "MID SUSSEX DISTRICT (SOUTHDOWN FARM, KEYMER) DIRECTION 1986"

SCHEDULE

"The erection or construction of gates fences walls or other means of enclosure not exceeding one metre in height where abutting on a highway used by vehicular traffic or two metres in height in any other case and to the maintenance improvement or other alteration to any gates fences walls or other means of enclosure so long as such improvement or alteration does not

increase the height above the height appropriate for a new means of enclosure" being development comprised within Class II 1, of Schedule 1 to the General Development Order 1977 and not being development comprised within any other class
