








Main Issues

- Effects on ecology and trees











The building will be scaffolded, not only to provide access for necessary repairs but also to support the structure. The roof tiles will be carefully removed and set

Front elevation - North




Side elevation - West Weish slates on battens on counter battens on rigid insulation and ply laid over rafters Proposed insertion of 3 No. new windows on western elevation to match existing on eastern elevation. Western elevation obscured with vegetation so openings on this elevation have not been established. All existing timber framing to be repaired or replaced where necessary, subject to discussion with Conservation officer. All existing timber framing to remain as original envelope and insulated wals inserted internally independent of external framework







Proposed main elevation for cattle barn - south elevation, field side Scale 1:200

Vertical timber boarding separated by max, 25mm air gap






Proposed end elevation to field - East Scale 1:200








Proposed main elevation for machinery store - north elevation towards yard Steel portal frame building - Shufflebottom or similar with concrete plinth Scale 1:200




Proposed main elevation for machinery store - south elevation, field side Steel portal frame building - Shufflebottom or similar with concrete plinth Scale 1:200






