This draft was discussed at the first meeting of the newly reformed Affordable Housing Task and Finish Group which met on Wed 17th Jan. The meeting picked up from the work of the last Member group on this subject, focusing its recommendations and producing a clear work programme. It concluded that, rather than creating a new housing vehicle or enabling service, the best approach will be to focus our limited staff resources and S106 cash on supporting rural exception sites and Community Land Trusts. The next step is for Mike to produce a model of how a programme of support for such sites across the National Park might operate. We will then take this to Homes England and potential institutional investors to identify whether it is possible to attract matching funding.

### Strategic fund

#### OMT approvals:

1. Q1 - Winterbourne and Watercress, OMT approved £12,000.

2. Q1 - Big Chalk, OMT approved repurposing of funds (**£10,000**) previously awarded to now provide external support to develop NERC bid for submission in Sept. 2017.

3. Q2 - Chalk Streams mapping, OMT approved the repurposing of funds (**£4,000**) previously awarded to now contribute towards the costs of a new Arun and Western Streams Catchment area project officer post.

4. Q3 - CHaMP project officer extended for 2018 - additional £25,000 agreed.

5. Q3 - Active Access - SDNP to partially fund walking & cycling officer for a further 2 years for the purpose of this project - additional **£24,258** approved in total.

Summary: 3 new applications, total £61,258 allocated; 2 repurposing, total £14,000 (only £4,000 spent).

#### Notes:

- Secrets of the High Woods approx. £11,491 underspend from SDNPA contribution to be re-allocated back to SF.
- NERC bid unsuccessful. £10,000 application fund not spent & can return to SF pot (see point 2 above).
- Big Chalk ringfenced allocation (£150,000) can return to SF pot as consequence of unsuccessful NERC bid.
