Title of Report Decision	Changes to Partnership Management Plan Review Task and Finish Group Terms of Reference

Recommendation: The Authority is recommended to agree the changes to the Terms of Reference of the Partnership Management Plan Review Task and Finish Group as set out at paragraph 3.1 of this report.

I. Introduction

- 1.1 The Partnership Management Plan Review Task and Finish Group was set up at the meeting of the National Park Authority (NPA) on 19 October 2017.
- 1.2 The terms of reference of the group (Appendix 1) require that any amendment, variation or modification of the terms of reference can only be made by resolution of the NPA.
- 1.3 The Task and Finish Group has now begun to meet and is proposing that its terms of reference be amended as set out below.

2. Policy Context

- 2.1 The purpose of the Task and Finish Group (T&FG) is to oversee the process of prioritisation arising from the outputs of the strategic reviews of parts of the Partnership Management Plan and the reviews of policies and external drivers for change. The Group is overseeing the production of a draft of the revised PMP and, in particular, a new Delivery Plan for the period 2019-2024.
- 2.2 The revised PMP and new Delivery Plan will be considered by the P&R Committee prior to decisions being taken by the NPA. It is important that a core group of Members can oversee the whole process, but all Members have an open invitation to participate fully in the work of the T&FG. This follows the model used for the Local Plan Members Working group.
- 2.3 The process of producing a new Delivery Plan involves a wide range of external stakeholders, represented at the senior level by the South Downs Partnership. The T&FG will consider the views of the SDP when it is developing the revised Delivery Plan to ensure it includes prioritised contributions from partners as well as the SDNPA.
- 2.4 Once a new Delivery Plan has been agreed by the NPA, the priority contributions by the SDNPA will be reflected in the Corporate Plan. This sets clear priorities for the Authority's contribution, and the consequent budget and allocation of staff and volunteer resources, will be established.

3. Issues for consideration

- 3.1 Following discussion by the T&FG the following additions to the 'Outcomes and Deliverables' section of the Terms of Reference are proposed to ensure that the remit of the T&FG is wide enough to fully undertake its role effectively:
 - Review the South Downs Partnership to assess and make recommendations in relation to whether its role, purpose and membership are fit for purpose for delivering the 2019-2024 Partnership Management Plan.

- Develop a draft 2019-2024 PMP Action Plan that is accessible and is easy to engage with for a wide range of stakeholders for approval by the NPA.
- Resourcing of Plan Ensure a realistic level of ambition for the Action Plan given the resources available from the SDNPA and its partners and the opportunities to generate new income.

4. **Options & cost implications**

- 4.1 The changes are proposed in order to enable the T&FG to effectively deliver the outcomes expected of it. The authority could decide not to agree to the proposed changes, but this may prevent the group being able to effectively undertake its work and deliver the outcomes expected of it.
- 4.2 There are no costs implications of the recommended changes.

5. Next steps

5.1 If agreed the changes will take effect immediately and new terms of reference for the Task and Finish group will be published.
