Title of Report Decision	Project Approval – South Downs National Park Authority projects that contribute to the Changing Chalk Heritage Lottery Fund bid by the National Trust

Recommendation: The Committee is recommended to:

- I) Approve the release of £90,000 from the Strategic Fund for the Grazier project
- 2) Note the release of £25,000 from the Strategic Fund for the Dewponds project

I. Introduction

- 1.1 Part of the remit of the Policy and Resources Committee is to: "To have oversight of the Strategic Fund including approving project bids to the Fund in excess of £50k up to a maximum SDNPA contribution of £100k". Approval for project funding over £100k is part of the remit of the South Downs National Park Authority (SDNPA).
- 1.2 Following the approval process agreed for projects of this value; this report asks Members to approve the funding for the Grazier project. As both projects are part of the overall Changing Chalk Heritage Lottery Fund Bid by the National Trust the Committee is also asked to note the approval by Officers of the Dew Ponds Project.

2. Policy Context.

- 2.1 The projects relate directly to PMP outcomes as set out in the PIDs at the **Appendix I** and **Appendix 3**.
- 2.2 The changing Chalk project is a Heritage Lottery Fund bid which is being led by the National Trust. It aims to increase the extent, quality and connectivity of semi-natural chalk grassland in the Eastern South Downs: protecting and enabling a better understanding of the cultural and historic significance of chalk grassland. This will be achieved in line with the National Park's statutory purposes and management objectives by engaging, inspiring and finding relevant ways in which to involve local communities to deliver sustainable solutions for the management of the chalk grassland landscape, for the benefit of both people and nature. The project's primary objectives are to:
 - Improve habitat and species richness and the connectivity of chalk grassland in the Eastern Downs;
 - Support and work with landowners and farmers to enable sustainable management of chalk grassland;
 - Protect significant cultural heritage sites on chalk grassland sites;

- Change behaviours of local communities from Eastbourne to Worthing to secure the long term future of the chalk grassland habitat;
- Empower people to actively participate and become ambassadors for their landscape and heritage. The 'Changing Chalk' HLF Project Team is seeking to increase its understanding of communities living between Eastbourne and Worthing, who are underrepresented in their enjoyment of, and involvement with the South Downs and other local natural greenspaces. The insight gained from this work will assist the Team and its project partners in working with new audiences to develop and deliver programs of mutual benefit, and that achieve sustained change.
- 2.3 As one of over 20 partners to the bid, the SDNPA is asked to develop and deliver two projects, as part of a much larger programme of activity. Members need to make the decision now, as the National Trust need to be able to demonstrate commitment from partners in order to submit the bid. A map of the Changing Chalk project is at **Appendix 2**.

3. Issues for consideration

- 3.1 The purpose of the Grazier project is to employ a grazier to carry out specific targeted grazing in the Changing Chalk project area. The purpose of which, is to bring target priority chalk grassland sites back into favourable condition. The project aims to test approaches to establishing a sustainable grazing regime for nutrient poor chalk grassland as part of an economically viable business model that could support conservation grazing in future.
- 3.2 The evidence for the need for the project is a baseline survey carried out by the Sussex Biodiversity Records Office in 2016 which showed that 37% of the chalk grassland sites in the South Downs National Park (SDNP) were in unfavourable condition. One of the main reasons for this was cited as under grazing or. 118 of the 479 sites surveyed would benefit from an alteration to the grazing regime such as a change in stock density or use of different livestock breeds. The majority of the chalk grassland in the SDNP is in the Central and Eastern part of the SDNP. Therefore the Changing Chalk project area, Broadly Worthing to Eastbourne area of open downs was seen as the best place to pilot an innovative approach. Details of the grazier project are in the PID in **Appendix 1**.
- 3.3 The purpose of the Dewpond project is to enhance the biodiversity of the chalk downland landscape, through the targeted restoration of dewponds. It aims to establish a line of dewponds along the South Downs Way supported by accessible interpretation; develop a network of dewponds with the primary purpose of supporting wildlife and improving habitat connectivity and finally; where 'gaps' in habitat connectivity have been identified, start to populate these areas with targeted restorations are the creation of new dewponds.
- 3.4 Evidence suggests that of the 280 dewponds thought to have existed in the region, almost 70% have either lost or are in poor condition. Following their use initially as sources of water for livestock grazing the slopes of the downs, their use has come to include support for networks of habitats for wildlife. Wildlife will benefit from a network of waterbodies no more than 1500m apart. Extensive work on the location and condition of dewponds carried out by a volunteer has enabled the project to define which dewponds to target in which areas. Details of the approved Dewpond project are in the PID in **Appendix 3**.

4. **Options & cost implications**

- 4.1 The total project cost for the Grazier project is £360,000 of which the SDNPA is asked to contribute £90,000, in cash and £176,000 in-kind support. This is split into two phases the first is for two years and is for £48,000 in cash split between year 1 and year 2. The second is for three years and is for £42,000 in match, spread evenly across years 3-5. The in-kind support is split equally over the five years of the project and is £32,200 per annum.
- 4.2 The total cost for the Dewpond project is $\pounds 144,500$ of which the SDNPA will be contributing $\pounds 25,000$ in cash and $\pounds 21,400$ in in-kind support. The project is split into two phases, the first is for two years and is for $\pounds 500$ cash and $\pounds 5,000$ in in-kind support, both in

year 1. The second is three years and is for \pounds 24,500 in cash and \pounds 16,400 in in-kind support both in year three.

- 4.3 The table below sets out the impact of these projects on the Strategic Fund. The unallocated sum for each financial year until 2021-22 includes the current commitment of £220,000 per year to the Strategic Fund, minus any other projects currently allocated funding.
- 4.4 Members should note that for the 2022-23 financial year, an assumption has been made about how much funding will be allocated to the Strategic Fund by the Authority as part of its budget setting round. As part of the report on the Medium Term Financial Strategy which is due to go to the SDNPA meeting on 22nd March it will be recommended that the SDNPA continues to contribute £220,000 to the Strategic Fund per annum.
