#### A. POLICY, PRACTICE, FUNCTION OR PROJECT TO BE ASSESSED

### A1. Please describe what are the main aims, objectives, purpose and intended outcomes of the policy or function?

The Joint Wealden Heaths Phase II Special Protection Area Supplementary Planning Document (SPA SPD) is to provide guidance to applicants where development proposals will result in a net increase in residential development within 400 metres of the Wealden Heaths Phase II Special Protection Area.

It sets out the approach that the Council and the South Downs National Park Authority will take to help meet the needs for residential uses where the need cannot be met solely outside of the 400 metre buffer zone (specifically Gypsy, Traveller and Travelling Showpeople accommodation and rural affordable housing exception sites).

This stage of the process seeks views on the draft SPA SPD, which will help inform the final document adopted by both authorities.

#### A2. Is this policy or function associated with any other Council policy or priority?

The SPD expands on Joint Core Strategy Policies (Local Plan Part 1), specifically Policies CP14: Affordable Housing in Rural Communities, CP15: Gypsies, Travellers and Travelling Showpeople and Policy 22: Internationally Designated Sites.

As set out in the Housing and Planning Act (2016), the Council has a duty to assess the accommodation needs of those residing in caravans (including Travellers); and under the Equality Act (2010) the Council must have due regard to eliminate unlawful discrimination and advance equality opportunity between people who share a protected characteristic and those who do not.

### A3. Who are the intended beneficiaries/stakeholders of the policy or function? How many people are affected and from what sections of the community?

The impact is district wide (including South Downs National Park) for new residential proposals within 400 metres of the Wealden Heaths Phase II Special Protection Area.

The SPD addresses the need for specific members of the community, including those requiring affordable housing in rural areas and Gypsies, Travellers and Travelling Showpeople.

#### A4. Is the policy/function corporate and far-reaching?

The SPD has to be adopted by the Council prior to it carrying full weight in the determination of planning applications. Once adopted, it is a material planning consideration for development proposals seeking planning permission in the district (including within the SDNP).

### A5. Are you expecting to make any significant change to the policy or service in the near future? If so, please give details.

This is a draft SPD and is subject to change until it is adopted by the Council for use in the determination of planning applications. This Equality Impact Assessment scoping assessment form accompanies the draft SPA SPD process of preparation. The draft SPA SPD is therefore subject to change following consultation and throughout the process until adopted.

Following adoption, the outcomes from the implementation of the SPA SPD will be monitored and the results documented in the Monitoring Report, which is produced annually. The results of monitoring will determine whether future updates are made to the SPA SPD.

#### A6. Is this a new or existing policy or function?

It has historically been very difficult to find sites to allocate for Gypsy, Traveller and Travelling Showpeople accommodation. A number of known existing pitches and plots already lie within the 400 metre SPA buffer which may have the possibility to be expanded. With regard to affordable housing in rural areas, through a call for sites, only two sites have been promoted both of which are located within the 400 metre SPA buffer zone.

The East Hampshire District Joint Core Strategy: Habitats Regulations Assessment sets out the approximate amount of windfall dwellings which would be allowed to come forward within the plan period within 400 metres of the Wealden Heaths Phase II Special Protection Area. However, monitoring of the early years of the plan period has demonstrated that a significant number of windfall schemes for dwellings have been granted planning permission within the 400 metre buffer zone. Therefore, in 2015 the Council commissioned a reassessment of the windfall allowance within 400 metres. The results of this work demonstrated that the windfall allowance could be increased slightly.

There is therefore a need to safeguarding the remaining windfall allowance within 400 metres of the Wealden Heaths Phase II Special Protection Area for Gypsy, Traveller and Travelling Showpeople accommodation and rural exception sites to help both planning authorities try to meet the districts identified needs for such accommodation.

#### B. EVIDENCE/ DATA and CONSULTATION

### B1. What monitoring or other information do you have about relevant target groups, which will show the impact of the policy or function?

A eight week public consultation will gather the views of the local community and stakeholders. The consultation will attempt to seek the views of the community, including those who do not regularly engage with Local Plan consultations.

The impact of the SPA SPD will be monitored in the Monitoring Report, prepared annually. It will take time to collect data, given the time it takes from planning permission being granted to completion and occupancy of developments.

### B2. Have you compared the data you have with the equality profile of the local population? What does it show?

Whilst the Council has not previously monitored the profile of respondents to Local Plan consultations, it is generally known in planning that respondents tend not to be well represented by minority or less heard groups, and representations generally are made by settled, well established, middle to older age people.

### B3. Have you identified any improvements or other changes that could be made from monitoring the data?

Particular care will be taken to ensure that a broad and representative cross section of the district's communities is consulted.

The Council and South Downs National Park Authority websites will be used to advertise the consultation, and Council officers will raise awareness of the consultation internally across services, so awareness can be raised through known contacts (such as development management team).

### B4. Have you consulted or involved external stakeholders about the policy or function? If so, what were their views?

Prior to the public consultation, the Environment Agency, Historic England and Natural England were consulted on the Habitat Regulations Assessment (HRA) and Strategic Environmental Assessment (SEA) screening assessment. The screening assessment forms part of the consultation documents. These three consultees will be consulted formally during the consultation.

### B5. Have you undertaken any consultation with staff to assess their perception of any impacts of the policy or function? If so, what has been learnt from them?

Internally, early engagement took place with Policy Officers at East Hampshire District Council and South Downs National Park Authority. Natural England was verbally introduced to the concept regarding safeguarding sites within 400 metres for the Traveller Community early in the process. All welcomed the safeguarding of sites within the 400 metre buffer zone.

### B6. Please provide information about any other consultation, research, or involvement undertaken in relation to this impact assessment.

Research was carried out to provide the evidence to justify the safeguarding of sites for the Traveller community and affordable housing in the rural communities. This information is detailed in the SPD.
