As per previous comments, the Reg 16 version of the NDP will need to refer to the most up to date stage of the South Downs Local Plan. Policy SEA2 - Design	We welcome the new design policy and related Design Guide for Seaford. We recommend that a criterion is added to the policy for development that is likely to have an impact on the National Park, for example because of views to and from the site. This criterion should support a landscape led approach to design	Welcome the new policy and recommend an extra criterion to have a landscape led approach to design for sites likely to have an impact on the National Park. We would be happy to discuss the

Policy SEA6 – Development on the Seafront	We welcome the changes made through the new part c) in the policy following our previous comments on protecting the setting of and views to and from the South Downs National Park, Heritage Coast, the shoreline and the Seaford Head Gateways. We reiterate our previous comment that for clarity the Seafront Area to which this policy applies is identified on the Proposals Map.	We welcome the changes to the policy through the new part c). Recommend that for clarity the Seafront Area to which the policy applies is identified on the Proposals Map.
Policy SEATT – New Business Space	This policy is now carrying forward an allocation from the Lewes Local Plan 2003, policy SF8. The allocation is in the area of the site nearest to and sharing a boundary with the National Park. To clarify it is recommended that the Inset Map on page 42 clearly shows this area where the new policy applies, as distinct from the rest of Cradle Hill Industrial Estate.	Recommend that the Inset map on page 42 shows the area covered by the allocation and therefore where the new policy applies as distinct from the rest of Cradle Hill Industrial Estate.
	We recommend that the policy and therefore the design of any future development takes a landscape led approach that seeks to conserve and enhance the setting of the National Park and mitigates against visual impact on the landscape. It is recommended that the South Downs Integrated Landscape Character Assessment (SDILCA) is referenced in the supporting text to inform the design of any future development, specifically Landscape Type A: Open Downland, A1: Ouse to Eastbourne Open Downs http://www.southdowns.gov.uk/wp-content/uploads/2015/03/ILCA-Appendix-A-Open-Downland.pdf	Recommend a landscape led approach to the policy as described in the comments opposite. We would be happy to discuss the landscape led approach on this site further with Seaford Town Council.
	We are concerned that the detailed criteria in the policy were created before the formation of the National Park and may not achieve a landscape led approach to the design. We would be happy to discuss the preferred landscape led approach further with Seaford Town Council in developing this policy.	

Community Aspiration I	Reiterate our previous comment that we would also welcome a co-ordinated and joint approach to signage and any fencing on Seaford Head and cliffs and the Heritage Coast overall.	Recommend inclusion in Aspiration I mention of co-ordinated and joint approach to signage on the Heritage Coast within Seaford Parish.
Community Aspiration 4	In reference to our earlier comments we appreciate that the Steering Group have contacted the Environment Agency asking for SDNPA to be consulted on future flood defence strategies. We would welcome this inclusion in the consultation process and recommend this is reflected in the wording of the Community Aspiration. Suggested sentence to be added "When appropriate the South Downs National Park Authority (SDNPA) should be consulted on any future flood defence strategy given the impact this can have on the natural appearance of the Heritage Coast."	Recommend the inclusion of the SDNPA in any consultations on flood defence strategies. Suggest adding to the Community Aspiration the sentence in the comments opposite.
