| Title of Report<br><b>Decision</b> | Update on the progress of the Review of the Hampshire Minerals and Waste Plan (2013) |

**Recommendation: The Authority is recommended to:** 

- 1. Agree that an update to the Hampshire Minerals & Waste Plan (2013) is not required at this time, but that a further Review will begin in 2020.
- 2. Approve that a summary of the review process and the decisions be consolidated and published on the SDNPA website as the '2018 Review of the Hampshire Minerals & Waste Plan'.
- 3. Agree that a programme of on-going engagement with interested parties commences following publication of the '2018 Review'.

#### I. Introduction

- 1.1 The Hampshire Minerals and Waste Plan 2013 (HMWP) was prepared by the South Downs National Park Authority (SDNPA) in partnership with the Hampshire Authorities (Hampshire County Council (HCC), New Forest National Park Authority, Portsmouth City Council, and Southampton City Council).
- 1.2 The National Planning Policy Framework (2018) requires that Local Plans should be reviewed to assess whether they require updating at least once every five years. The HWMP was adopted in October 2013 and therefore a Review was required to be undertaken in 2018.
- 1.3 A recent update to the Planning Practice Guidance suggests that if a local planning authority decides not to update their policies, they should publish the reasons within 5 years of the adoption date of the plan.
- I.4 Each Authority involved in the preparation on the HWMP must publish the decision.
- 1.5 Following an assessment of how each policy has performed so far in the lifetime of the HWMP, the Authorities are proposing to undertake a Review of the HWMP in 2020.
- 1.6 The purpose of this paper is to provide a summary of the assessment process and to ask the Authority to agree that the summary assessment be published in due course. The National Park Authority is asked to agree that a further Review should take place in 2020. The 2018 Review Assessment document will be published once all the partner Authorities have agreed the process through their respective organisations.

- 1.7 A copy of the Report prepared by officers at HCC for their Executive Member for Transport and Environment provides more detail of the assessment that was undertaken and is appended to this Report.
- 1.8 A report was taken to Planning Committee on 11 April 2019 asking for their recommendation to the NPA, which was agreed by the committee. No changes have been made to this report as a result of planning committee's deliberations.

## 2. Policy Context.

2.1 The preparation and adoption of Minerals and Waste Local Plans is a statutory duty of the National Park Authority. The Plans carry forward the vision and policies of the Partnership Management Plan.

## 3. Findings of the Review

- 3.1 The Review assessed each policy to determine its effectiveness based on the data contained within the relevant Monitoring Reports produced since the adoption of the Plan. Each policy was provided with a RAG (Red, Amber or Green) Monitoring Summary to determine how it has performed against the relevant monitoring indicator. The Hampshire Minerals & Waste Plan contains 34 policies. Of these, seven policies were initially categorised as 'Monitoring shows some issues to be reviewed' (Amber) and seven as 'Monitoring shows issues to be reviewed and may need to be addressed' (Red). The remaining 20 policies were categorised as 'Monitoring shows no issues' (Green).
- 3.2 The Development Management policies (Policies I 14) which control the impacts of development are considered to be working effectively with only one Amber and one Red rating amongst them. Policy 14 (Community benefits) was categorised as Red. This is because implementation of this policy has highlighted that it does not relate directly to work done by the Minerals and Waste Planning Authority (MWPA); instead it refers to bilateral agreements that do not include the MWPA. Should the Plan be updated, it is considered that this policy could be removed and support for community benefits provided in the supporting text of Policy I.
- 3.3 The reasons for not updating the Plan are summarised as follows.
- 3.3.1 The assessment of Waste Policies concluded:
  - In general, the waste forecasts have been relatively accurate;
  - Landfill capacity is identified as not meeting the forecasted need, however, Policy 32 allows for additional landfill capacity and there is also reserve capacity.
- 3.3.2 The assessment of Mineral Policies concluded:
  - The landbank and permitted reserves of all sand and gravel, silica sand and brick-making clay are not meeting their required levels. However, review of the mineral supply policies has highlighted that these do not exclude further development proposals to come forward and would be supported where a shortfall in supply is identified. The policies are considered to be flexible and enable development, where required;
  - The allocations in the HWMP are coming forward (relatively to the timescales set out in the HMWP) as well as unplanned opportunities; and
  - The landbank is being affected by a delay in decision-making through planning applications which is not the result of policy.
- 3.4 One of the key issues in the Review for the SDNPA is the issue of a declining landbank for soft sand across the region. The SDNPA is currently working closely with East Sussex, West Sussex and Kent to understand the implications for our Plan Areas. Wider discussion leading to a Position Statement is taking place at a regional level through the South East England Aggregate Working Party (SEEAWP). The Hampshire Authorities are involved in this work and the Position Statement will inform the 2020 HWMP Review.

#### 4. Options & cost implications

- 4.1 The Plan Review process is statutory.
- 4.2 There is a cost for preparing a Minerals and Waste Plan for the Hampshire part of the South Downs National Park. The cost is shared proportionately amongst the Hampshire Authorities and costs to the SDNPA are covered by the Planning Policy budget.

### 5. Next steps

- 5.1 The findings of the Review along with the decision on updating the HMWP need to be published and it is proposed to do this by making the '2018 Review of the Hampshire Minerals & Waste Plan' public as soon as possible.
- 5.2 It is proposed that a further Review is conducted in 2020. The '2020 Review' will begin with a workshop for stakeholders in late 2019.
- 5.3 No documents will be published or actions taken until all the partner Authorities have agreed the approach through their respective decision making processes.
