Title of Report	Save and Carry Forward Supplementary Planning Documents to the South Downs Local Plan
Purpose of Report	To save and carry forward Supplementary Planning Documents to relevant policies of the South Downs Local Plan

Recommendation: The Committee is recommended to:-

- I) Save and carry forward Buriton Village Design Statement as a Supplementary Planning Document
- 2) Save and carry forward East Dean and Friston Village Design Statement as a Supplementary Planning Document
- 3) Save and carry forward Liss Village Design Statement as a Supplementary Planning Document
- 4) Save and carry forward Lodsworth Parish Design Statement as a Supplementary Planning Document
- 5) Save and carry forward Worldham Village Design Statement as a Supplementary Planning Document
- 6) Save and carry forward Wealden Heaths Phase II Special Protection Area Supplementary Planning Document

I. Summary

1.1 On adoption of the South Downs Local Plan, all inherited saved Local Plan and Joint Core Strategy policies were replaced by the policies of the South Downs Local Plan (SDLP). There are number of Supplementary Planning Documents (SPD) which were previously adopted as supplementary to saved Local Plan and Joint Core Strategy policies. Officers have reviewed all these SPDs for their relevance and consistency with the new Local Plan policies. Where SPDs are still relevant and where they are consistent with the new Local Plan, it is proposed to save and carry forward these SPDs as supplementary to the Local Plan.

2. Background

2.1 Supplementary Planning Documents (SPD) add further detail to the policies in the development plan. They can be used to provide further guidance for development on specific sites, or on particular issues, such as design. SPDs can be prepared by the Local Planning Authority or local community to provide more detail on policies in adopted Development Plan Documents (DPDs). SPDs should align with policies contained in the

- Development Plan. They should also be consistent with national planning policy. SPDs can be material consideration in planning decisions, but are not part of the development plan.
- 2.2 A number of communities across the National Park have prepared Village Design Statements (VDS) and where appropriate these have been adopted by the SDNPA as SPD. VDSs describe the character of the landscape including the built environment of their parish and include guidelines to help ensure that this character is conserved and enhanced in any new development in the area. These VDSs were adopted as SPD to the design policies set out in the relevant DPD at the time of adoption.
- 2.3 Officers have reviewed all the VDS currently adopted by the SDNPA as SPDs. This review indicates that the SPDs are consistent with the new Local Plan policies and can be carried forward post the adoption of the South Downs Local Plan. There are five VDSs that have previously been adopted as SPDs and are now proposed to be saved and carried forward by the SDNPA as supplementary to Policy SD4: Landscape Character and Policy SD5: Design, of the SDLP. Both policies SD4 and SD5 require development proposals to take into account VDSs. All the VDSs proposed to be saved and carried forward were subject to the necessary checks at the time of their original adoption. Officers have reviewed these VDSs and are content that they are appropriate to be saved and carried forward. The VDSs will be periodically reviewed to assess whether they need updating or revisions.
- 2.4 Wealden Heaths Phase II Special Protection Area SPD sets out the approach the SDNPA and East Hampshire District Council will take to ensure there are no adverse effects on the integrity of the SPA, which is internationally recognised and designated for its breeding bird species. The SPD safeguards the remaining windfall allowance within 400 metres of the Wealden Heaths Phase II Special Protection Area for Gypsy, Traveller and Travelling Showpeople accommodation and rural exception affordable housing only as the need for these uses cannot be solely met outside of the 400 metre buffer zone. Policy SD10 of the South Downs Local Plan requires that any new housing that is proposed within 400 metres of the Wealden Heaths Phase II SPA undertake a project-specific Habitats Regulations Assessment (HRA). It is therefore considered appropriate to save and carry forward the SPD as supplementary to Policy SD10: International Sites.
- 2.5 Other SPDs reviewed by officers and not considered to be relevant or consistent with the new Local Plan are:
 - Wealden Design Guide (2008) this contains guidance which conflicts with SDLP policies. SDNPA is preparing its own Design Guide which will be adopted as SPD in due course.
 - East Hampshire District Council Guide to Developers' Contributions (2014) this has been superseded by the adoption of the SDNPA Community Infrastructure Levy. In addition, the SDNPA is preparing an Affordable Housing SPD which includes in lieu financial contributions and will be considered by Planning Committee in July..
- 2.6 SPDs are subject to Regulations, including a specific process of consultation and engagement with relevant parties, before they can be adopted as an SPD. The Town and Country Planning (Local Planning) (England) Regulations 2012 (part 5) require Local Planning Authorities to consult on proposed SPDs for a minimum of 6 weeks. The details of consultation undertaken by the SDNPA on SPDs prior to their adoption are set out in Table I below. Unlike DPDs, SPDs do not go through the formal submission or examination process.
