


vii. Securities

- 1. You should list the details of any beneficial interest (see (2) below) that you or your partner have in the securities of any company, industrial and provident society, cooperative society, or other body corporate that, to your knowledge, has a place of business or owns land in the National Park. - 3. "Securities" means any shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme (within the meaning of the Financial Services and Markets Act 2000) and any other securities of any description, other than money deposited with a building society.



viii. Other Personal Interests

Declaration

I recognise that it is a breach of the Localism Act 2011 and a criminal offence, if without reasonable excuse; I:-

- a) fail to give notice to the Authority's Monitoring Officer of any disclosable pecuniary interest which I have or my partner has within 28 days of becoming a member.
- b) fail to disclose at a meeting of the Authority (or any committee or sub-committee of the Authority) an unregistered disclosable pecuniary interest in any matter to be considered at the meeting of which I am aware (unless the interest is "sensitive" within the meaning of the Localism Act 2011, in which case I must disclose merely the fact that I have a disclosable pecuniary interest in the matter concerned),
- c) in the circumstances of (b) above, fail to give notice to the Authority's Monitoring Officer of the interest within 28 days of the meeting (unless the unregistered interest is the subject of a pending notification); or
- d) participate in any discussion or vote on the matter in which I have a disclosable pecuniary interest (unless I have received a dispensation in accordance with the Localism Act 2011).

Furthermore. I recognise that it is a breach of the Localism Act 2011 and a criminal offence, to provide information that is false or misleading and I:-

- a) know that the information is false or misleading; or
- b) am reckless as to whether the information is true and not misleading.
