Title of Report  Decision	Review of Appointments of Committees and Outside Bodies

### **Recommendation: The Authority is recommended to:**

- I. Amend the size of the membership of the Policy & Resources Committee to 13 members
- 2. Agree the revised membership of Committees attached at Appendix I
- 3. Note the appointment of Janet Duncton as a SDNPA representative on the South Downs National Park Trust

#### I. Introduction

- 1.1 At its AGM in July 2019 the Authority agreed its annual review of arrangements for discharging its decision-making responsibilities, in particular the delegation of responsibilities, and making of appointments, to Committees.
- 1.2 Due to the proximity of the AGM to the conclusion of the parish election process, the Authority took the decision to revisit the appointments after the AGM to ensure the appropriate allocation of members to committees. In order to ensure the effective running of committee in the short term the authority also agreed an increase in the size of the P&R Committee to 14.
- 1.3 Under Schedule 7 Para 13 of the Environment Act 1995, the Authority has a duty to secure that the division of local authority appointed Members and Secretary of State appointed Members on any Committee is (as nearly as possible using whole numbers) in the same proportion as required in the case of the Authority itself. For the SDNPA this equates to an approximate 50/50 split of LA and SOS members on each the committees, however a failure to comply with this requirement does not, in itself, invalidate the proceedings of any committee.

#### 2. Issues for consideration

- 2.1 The proposed new committee membership is set out at Appendix 1.
- 2.2 In summary the proposed changes are:
  - Ian Phillips ceases to be a member of the Planning Committee.
  - Vanessa Rowlands ceases to be a member of the P&R committee and joins the Planning Committee

- 2.3 The Chair has proposed the transfer of lan Phillips from being a formally appointed member of Planning Committee to be an ex-officio member by virtue of his role as Deputy Chair, which status similarly applies to his membership of the Policy and Resources Committee. This will enable him to focus on his responsibilities as Deputy Chair including his role on the Appointments Management and Standards Committee, and in contributing to succession planning as a number of Secretary of State members reach the end of the their maximum terms of office in 2020.
- 2.4 The Chair has also proposed removing Vanessa Rowlands from the P&R committee. This will enable this committee to revert to its intended size, as set out in the 2017 Governance Review. Vanessa Rowlands will fill the vacancy created by Ian Phillip's departure from the Planning Committee. This will contribute to satisfying the requirements in relation to the balance between Local Authority and Sec of State members on the Planning Committee (whilst noting the vacancy for a new SoS Member of the authority is outstanding), and will provide for a better geographical spread of members from across the National Park on that Committee.

#### 3. Appointments to Outside Bodies

- 3.1 In exercising powers delegated to him under Standing Order 26.3, the Chief Executive, in consultation with the Chair of the Authority, has agreed the appointment of Janet Duncton as a SDNPA appointed trustee to the South Downs National Park Trust.
- 3.2 This power is exercisable when the Chief Executive is of the view that the appointment cannot be deferred until the next Authority AGM. In this case, in order to support the effective operation of the trust, The Chief Executive was of the view that this requirement was met and the appointment was necessary. The appointment meets the requirements of the outside bodies protocol. Further, it is a requirement that the Chief Executive report any such appointment to the first available meeting of the Authority, this report fulfils that requirement.

#### 4. Options & cost implications

4.1 The costs associated with the administration of the decision making structures of the Authority are met from within the Authority's core budget.

#### 5. Next steps

5.1 Officers will take the necessary administrative steps to enact the new committee memberships and outside body appointments.
