# ITEM 5: AUDITED STATEMENT OF ACCOUNTS AND LETTER OF REPRESENTATION

- 6. The Principal Accountant introduced report PR19-20-08 and reminded Members of the report content.
- 7. The Committee commented that:
  - For future years it would be in the Authority's interest to broaden out the accounts to demonstrate the wider impact the Authority makes in the National Park, including additional money levered in through the work of the Authority. This should also include Natural capital accounts.
  - An integrated approach to reporting the accounts, taking a "triple bottom line" approach would better demonstrate the impact of the National Park Authority and help demonstrate the value the National Park Authority adds to the National Park.
- 8. In response to questions officers clarified that:
  - Mortality assumption figures were provided by the actuary and were based on national workforce trends.

- There was no historic risk arising from staff who had transferred into the Authority, although staff who joined the Authority from the Joint Committee would have joined with previous pension rights.
- The McCloud judgement had identified a number of historical equalities issues that related to age discrimination, but the impact of this ruling for the Authority was not fully known as legislation to correct the issues identified was still awaited. It was expected that the risk to the Authority was very low.
- It was noted that the general reserves were held at the CIPFA recommended level of 5%, although the Authority did have other allocated reserves such as for planning and estates. There was a risk that the Authority was seen to be holding too much in reserve and this needed to be kept under review.
- Scenario planning for different financial positions had been undertaken in previous years but not since the fixed grant arrangement had been introduced. There was currently no indication that National Park Authority grants would be subject to cuts.
- Officers undertook to look into how integrated reporting could be developed and a report would be bought to the next meeting of the committee to outline how this may be delivered.
