Title of Report (Decision)	Wallands SuDS in Schools Contract 2021-2022

Recommendation: The Committee is recommended to

- 1) Approve the commencement of a procurement process leading to the appointment of a contractor to deliver the Wallands SuDS in Schools project from February 2022.
- 2) Approve delegation of authority to the Chief Executive to award contracts for the above, following a competitive process carried out under the terms of the Public Contracts Regulations 2015.

I. Introduction

- 1.1. The Aquifer Partnership (TAP) is a collaboration between the SDNPA, Environment Agency, Southern Water and Brighton & Hove City Council working together to protect the Brighton chalk aquifer and raise awareness of its presence and importance.
- 1.2. TAP, through the SDNPA, wishes to tender for the construction of an exemplar Sustainable Drainage System (SuDS) at Wallands Primary School in Lewes. This is part of TAP's SuDS in Schools programme.
- 1.3. P&R Committee are not being asked to grant the funding. This has already been granted by the SDNPA from Community Infrastructure Levy (approved by Planning Committee on 14th October 2021). However as the value of this contract is £150,000 approval is required from the P&R Committee for the procurement process to commence.

2. Policy Context

- 2.1. The decision to commission this work contributes towards delivering Outcomes 2 (resilient landscape), 3 (habitat network) and 8 (wise use of resources) of the PMP.
- 2.2. The project is part of programme 7 of the South Downs National Park Climate Action Plan.

3. Issues for consideration

- 3.1. TAP intend to procure a contractor that has high attention to detail and commitment to delivering a gold-standard exemplar project.
- 3.2. The contractor will be required to deliver the scheme as designed by Landscape Architects who will also be appointed as Contract Managers for this project.
- 3.3. Monitoring of the site over a defects period with maintenance, repair or replacement will also be required.

4. Options & cost implications

- 4.1. Procurement of the construction contract is the necessary next step in the delivery of the Wallands SuDS in Schools project.
- 4.2. The competitive tender process will ensure value for money .

5. Next steps

5.1. An open process will be undertaken to procure the construction contract, with a single stage tender being advertised through the 'In-Tend' portal.

The project contributes to the guiding principles of living within environmental limits by and promoting good governance by undertaking thorough consultations with school staff and pupils and encouraging pupil participation throughout the process, including elements such as democratic voting on decisions. It also promotes awareness of and encourages sustainable behaviour among staff, Members and volunteers by disseminating information on the SuDS in Schools project and inviting SDNPA personnel to visit the project.

7. Risks Associated with the Proposed Decision

- 7.1. There are four well documented risks with any procurement and those are listed as follows;
- 7.2. Commercial Risk That either the price objectives are not achieved up front or there are other costs that arise during the contract that diminish the overall benefits. SDNPA will mitigate this risk by appointing an experienced Contract Manager who can oversee the

- construction and any possible increased costs, working to mitigate these. This risk is also mitigated through the competitive tendering process.
- 7.3. Technical Risk This concerns the difficulty in the market being able to deliver to the specification. This risk is mitigated by a thorough evaluation process including ensuring examples of similar previous works are given and that references are included as part of the process.
- 7.4. Performance Risk This concerns the ability of suppliers to perform consistently over the life of the contract to deliver the planned benefits. Performance is managed through continuous engagement with the contractor on a number of levels to ensure levels are maintained and issues are resolved at an early stage.
- 7.5. Contractual Risk This covers things like being able to remedy the shortcomings in the contractors' performance without severely damaging the contract and about avoiding reliance on the contracted supplier as the contract develops. It is impossible not to rely on a contracted supplier in a contract such as this and it is important that the evaluation at the outset, in both stages, capability and award, is thorough.
- 7.6. In Public Procurement, there is also the Legal Risk, where a procurement is found unsound in law, through either the remedies directive or the public procurement rules. The main mitigation to this is to have a procurement professional responsible for the exercise and to keep Legal Services involved at the right stages.
