

# Register of interest in Self-Build and Custom

### Association Application Form

The Self-build and Custom Housebuilding Act 2015 places a duty on local authorities in England, to keep and have regard to a register of people (individuals or groups), who are interested in self-build or custom build projects in their area. This register will help inform the authority of the level of demand, for self-build and custom build plots in the South Downs National Park.

We shall use the information to explore ways in which it might be possible, for people and plots to be brought together. Registration does not however guarantee that a suitable plot will be identified, or become available.

This application form is for any group wishing to register an interest in self-build or custom build. For the purposes of the Self-Build and Custom Build Register, a group wishing to register is referred to as an Association.
