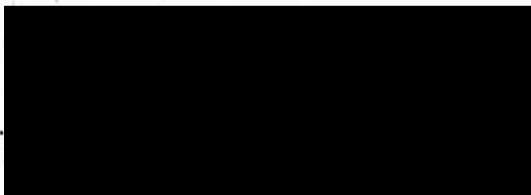
I recognise that it is a breach of the Localism Act 2011 and a criminal offence, if without reasonable excuse; I:-

- b) am reckless as to whether the information is true and not misleading.

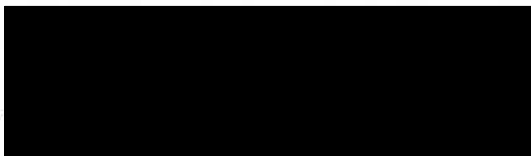
