### **Eligibility:**

Age: 18 -25 years old Have never been to the South Downs National Park Must be willing to be quoted and have their name mentioned on social media Resident within mainland United Kingdom

**Entry requirement:** Eligible people are requested to do a 2 minutes video or 200 word write-up on the question 'why would you love to spend a day at the South Downs National Park'. The answer must highlight clearly your interest, expectations and plan for a day at the South Downs.

**Prize:** 3 top entries will win an all-expense-aid trip from London to the South Downs.

## **Terms and Conditions**

People below the age of 18 or above the age of 25 cannot participate in this competition.

## **Closing date**

The Competition will close at midnight on Tuesday 17th May 2022.

Entries received after this deadline will not be accepted.

No responsibility is accepted for network, computer hardware or software failures of any kind which may restrict or delay the sending of your entry. No responsibility is accepted by SDNPA for entries lost, delayed, misdirected, incomplete, or which cannot be entered for technical or other reasons. Proof of entry is not proof of receipt.

# Entry details

All entries, whether video recording or write-up, must be submitted electronically by email to <u>eventbookings@southdowns.gov.uk</u>. Entries will not be accepted by post or hand. Written entries must be in PDF.

Video entries may be in MP4, MOV, WMV, AVI formats through a shared link.

Retouching / manipulation of digital images is accepted provided that all works are original works and not copies of other people's works.

You may not enter a write-up or recording that has been published elsewhere or has won a prize in any other competition.

# **Prizes and judging**

The winning entry will be officially announced in the South Downs National Park website and through our social media channels.

SDNPA may change the advertised panel of judges in the event of circumstances outside of its control.

The judges' decision is final and no discussion or correspondence will be entered into in respect of their decision.

The prizes are non-transferable.

Once the winner has been notified, he/she will need to provide full contact details including name, age, address, email address and photographic proof of identity in order to claim the prize.

By entering the Competition you release SDNPA from and against all claims and damages arising from or in connection with your participation in the Competition. You agree to comply with these Rules of Entry.

Details relating to the prizes will be sent to the winner within 10 days of the winner being announced.
