

Register of interest in Self-Build and Custom

Association Application Form

The Self-build and Custom Housebuilding Act 2015 places a duty on relevant authorities in England, to keep and have regard to a register of people (individuals or groups), who are interested in self-build or custom build projects in their area. This register will help inform the authority of the level of demand, for self-build and custom build plots in the South Downs National Park.

We shall use the information to explore ways in which it might be possible, for people and plots to be brought together. Registration does not however guarantee that a suitable plot will be identified, or become available.

Anyone seeking to land to build their own home can apply to be on the register providing they are eligible, that is they are at least 18 years of age and they are a British citizen, or a national of a European Economic Area State or a national of Switzerland.

The register is in two parts. Part I is all applicants meeting the criteria for a local connection to the South Downs National Park. Part 2 is all other applicants. A local connection is based on the responses given to this application form. The local connection criteria are shown on page 2 of this application form.

South Downs National Park Authority (SDNPA) has a duty to permit sufficient plots to meet the demand evidenced by the entries on Part I of the register. The entries on Part I and 2 of the register will be taken into account by SDNPA when making planning decisions in the National Park. Those on Part 2 of the register can still build their own home in the National Park. Being on Part I of the register provides no entitlement to receive any plot permitted by the SDNPA.

NOTES:

This application form is for any group wishing to register an interest in self-build or custom build. For the purposes of the Self-Build and Custom Build Register, a group wishing to register is referred to as an Association. If you are wishing to register as an individual, please complete the Individual Application Form.

To notify us of any changes to the information provided, for any member of the association, please complete a new application form and send this to the South Downs National Park Authority (SDNPA).

If you would like to be removed from the SDNPA's Self-Build and Custom Build Register, please make this request in writing to the SDNPA.

Once the application has been determined, we will contact you to notify you of the outcome. If your application has been successful, the information you provided will be recorded in the Self-Build and Custom Build Register.

Local Connection criteria

Any group applying for the register, whose individual members all meet at least one of the following criteria, a) to f), is considered to have a local connection and will be entered into Part I:

a) Have lived (as only home or principal residence) in the National Park continuously for at least the last two years; and/or

b) Have lived (as only home or principal residence) in the National Park continuously for three out of the last five years; and/or

c) Have lived (as only home or principal residence) in the National Park for a total of 15 years or more; and/or

d) Have immediate family^{*} who have lived continuously in the National Park for at least the previous five years; and/or

e) Have been employed in the National Park for a minimum of 16 hours per week continuously for the last two years; and/or

f) You are a member of the UK armed forces, or an ex-member of the UK armed forces whose service ended within the last 5 years.

* Definition of immediate family

A person shall be taken to be an immediate family member of another's family if he or she is the spouse, civil partner, mother, father, sister, brother, daughter, son of that other person or if he or she ordinarily resides with that other person as husband or wife or partner but without being legally married to (or in a civil partnership with) that person. Immediate family includes relationships as described above with adopted and step relatives.
