The Authority is asked to consider whether, in respect of Appendix 2 to Agenda Item 13, and Agenda Item 16 the public, including the press, should be excluded from the meeting on the basis that it is likely, in view of the nature of the business to be transacted or the nature of the proceedings, that if a member of the public were present during the items there would be disclosure to them of exempt information within paragraphs 1, 3 and 5 of Part 1 of Schedule 12A to the Local Government Act 1972, being information relating to an individual (Appendix 2 to Agenda Item 13) and information relating to the financial and business affairs of a particular person including the Authority and information in respect of which a claim to legal professional privilege could be maintained in legal proceedings (Agenda Item 16) and that in all the circumstances of the case, the public interest in maintaining the exempt information outweighs the public interest in disclosing the information. It is proposed that this conclusion be reached for the following reasons:

- in respect of Appendix 2 to Agenda Item 13, whilst there is a public interest in the transparency of Authority proceedings and the appointment of Co-opted Members, it is felt that on balance this is outweighed by the public interest in ensuring that an individual's right to privacy prior to their appointment is respected; and

- in respect of Agenda Item 16, whilst there is a public interest in the transparency of Authority proceedings and the governance of a local authority trading company, it is felt that on balance this is outweighed by the public interest in ensuring that the National Park Authority is able to fully consider the implications of its actions or proposed actions, with the benefit of specialist advice, without the disclosure of information that could undermine its position and/or the position of its Teckal company, or information relating to ongoing discussions between the Authority and a third party organisation.



High Level Targets



NATURE RECOVERY

Supporting action rebuild biodiversity (ReNature and Core Nature).

- To secure an additional 13,000ha, or 33% of land managed for nature by 2030 from a baseline of 25%.
- Maintain, enhance and/or restore existing key sites, habitats and species.

CLIMATE ACTION
