Thank you for your consultation. I would draw your attention to the submitted heritage assessment. This concludes that: Para 7.4

"Due to the low archaeological potential, the proposed development will not have any below ground archaeological impacts. Therefore, further archaeological investigation in support of the development of the site is considered to be unnecessary."

This is reiterated in Para 6.40 and 41 of the Planning Statement states "The accompanying Heritage Assessment has determined that based on available evidence the site has a low potential for all archaeological periods. While it is possible that unrecorded remains may be present, there is no evidence to suggest that such remains, if present, would be more than of local significance." "Due to this low archaeological potential, the proposed development will not have any below ground archaeological impacts with further archaeological investigation unnecessary to support the proposed development."

The Site appears to have been extensively impacted by modern development and the chances of as yet unrecorded archaeological features being uncovered during ground works associated with development is considered to be low. I would therefore concur with the conclusion of the heritage assessment and would not raise any archaeological issues.
