It has now been acquired by a final private owner who will seek to gain maximum capital gain from any development, and thus will seek the greatest commercial return. This must be rsisted at all costs, and public money will probably be needed to complete the tasks. There is opportunity for residential works, commercial and natural/leisure use, so long as very clear paramaters and boundaries are set. Any increase in residential and commercial use will result in major increases in traffic and congestion, on an already very busy local road network. The potential for environmental and natural habitat development must be preserved in the back area to the East of the site, to ensure its gradual re-integration with Downs to the North and East. The actual works in the centre of the site must be demolished to make way for the commercial potential. One suspects that the works buildings are full of asbestos - this will require significant funds and environmental care to remove before any re-development can take place. Blot, ugly and foresaken.

Landscape Nature Recovery That is what needs to be seized by a bold, 21st century NPA. Sadly, one could write: Authority's Lost Opportunity - three words that sum up the tenor of this AAP consultation. As the preamble to Q2 states, the site "is bounded to the west by the River Adur and farmland in the floodplain, to the north by chalk grassland, and to the south and east by farmland" – so heed the words of this description, to conserve and enhance, not create a development site with permanent industrial, business, commercial leisure and residential buildings. The appeal dismissed an earlier proposal for 84 homes, the AAP is proposing more than double this, up to five times as much. There is indeed housing need in the urban areas, but the SDNP should not be the golden ticket for urban housing authorities to dump their housing demand in a National Park, which "would generate traffic and would therefore put pressure on both the local and the strategic road networks". The SDNPA is not seeking to address this fundamental problem that any development would generate, instead it offers an oxymoron, "seeking to build back better, greener", surely it should be conserve and enhance, bigger, better and more joined up.
