Comments received

(R7/session 60914; member of public) Created **August 2nd 2022**

As a Heritage Railway enthusiast, I believe there may be a president to have a portion of the area held for a railway museum. If I am correct, just on third party accounts and rumour, the grounds still have sections of the original branch line servicing tracks goind towards some of the older buildings in need of repair. Along with the above point, if exceptions could be made on renovation budgets, external monetary services such as Camelot, and local contributions, the Adur Valley Line / The Steyning Line could be rebuilt, if anything similarly to the Bure Valley Railway. If either of these sound like potentially sound ideas to yourself / yourselves, please let me know and I'd be happy to have a further discussion about the ideas.

(R51/session 60894; Shoreham District Ornithological Society) Created **August 2nd 2022**

Opportunities to enhance Nature Based Recreation and Wellbeing SDOS funded, constructed, and continues to maintain a seat close to the west side Adur riverbank opposite the "Riverside" section. This provision has been in place for many years. Walkers and birders can take a rest here with a pleasant view across to the greenery opposite, barely aware of the old industrial buildings behind. Users regularly observe the Peregrines on the chimney, Ravens around the works, Common Sandpipers on the river and Kingfishers perched on overhanging bushes. All this "wellbeing" benefit will be lost if development is permitted directly facing onto the river without the screen of existing mature overhanging vegetation or if the development is higher or more prominent than existing buildings. The Society has for many years organized walks into Anchor Bottom to

the north of the site to attempt to observe the special species associated with the quarry. Access to the Cement Works site, however, has always been problematic and we encourage the SDNP in the development of a plan to consider the potential of parts of the site for nature conservation and associated nature-related recreation. There is a substantial ecological literature on the nature conservation value of abandoned mineral workings and it is likely that areas such as the 'Moonscape' presently have ecological interest that might be developed by future sympathetic management.

It would also provide a fantastic addition to our tourism with people visiting an amazing area of chalk land habitat; it could be part of the double bus tour for tourist who get taken to Devils Dyke and the Cement Works could/should be included to this.

Conservation Sitting within an area of outstanding naturel beauty, it feels clear to me that the natural integrity of the site remains intact. Within that, I am sure that I am not alone in feeling that this site does not need to become a further housing development - in favour of there being many many other areas that could benefit from regeneration instead. With my work, I currently lead on active pursuit programs that support young people with mood related mental health need. We use a variety or outdoor / outbound activities to make meaningful change in their lives. The challenges associated to this, is that there are no organised outbound adventure / outdoor provides within this area of the southeast. Any reference to previous youth groups or charities which took young people outdoors have long since been unprioritized, and capitalised venture providers have taken their place, generally alienating the vast majority of the families and young people from low social economic backgrounds. Yet the need to positive interaction, conservation and youth engagement with the outdoors remains as current as it has ever been. This aside, what is also apparent from our engagement with families and young people is that the understanding and appreciation for the need for conservation for what is literally on their doorstep has seemingly little or no localised focus; and therefore, it strikes me that we are not making enough of the resources on our doorstep as a result. Creating new jobs I suppose this is where my views converge. It strikes me that the site lends itself wonderfully well to the possibility of a mixed usage which focuses predominantly on the outdoor / outbound adventure industry; things such as mountain biking, orienteering, BMX, skate, crafts, woodwork, local conservations, conference and training for schools, forest schools, zip lining and more.... Using this area to bring together education, conservation, outbound adventure companies and industry strikes me as a perfect blend, whilst maintaining the iconic look and feel of the site. Outdoors vs Conservation vs Learning I work very closely with the Developing Mountain Biking in Scotland team. Withing their approach, huge funds have been allocated to the development of not just the trail network but promoting the sport and industry to enhance awareness of community participation in conservation but to also create a much-needed boost in their tourist industry. Of course I would love to see this site supporting local mountain biking clubs but the site itself and its locality has the ability to appeal to a much more focused and ambitious action of bringing more diverse groups / areas and industry together, perhaps to have the same emphasis on developing tourism by embracing an mixed outdoor activity centre which can: supports local communities with jobs and training vs works in partnerships with schools in the Adur / B&H area to support conservation and lend itself to utilising the natural resources of the site and locality to attract like=minded outbound companies to support these localised initiative whilst bringing in tourism revenue.

nature walks, sculpture trail - attractions that are sensitive and naturalistic - I think conserving and enhancing the flora and fauna and natural habitats is important. Cafe, visitor centre (industrial / farming museum); perhaps craft centre based around artist and craft workshops.

Lakes, SDNP heritage and Downland Centre, River activities - kayaking, boating. Nature observation hides for - birds/cliff habitats. Cycle routes - along riverside and extending

In addition, leisure outdoors activities such as climbing and an outdoor all-year ski run, or a downhill mountaining biking run, would be a huge benefit. Along with the SDNPA's duties to protect the landscape and biodiversity, we need to see: Car free development as a first option. Effective decarbonisation and motor vehicle traffic reduction both on site, and in the type of journeys made to the site, with minimal car parking whilst ensuring that people with disabilities have access and are not disadvantaged. Excellent active travel and sustainable public transport provision with full accessibility for disabled people.

In our submission we also seek to draw the attention of the SDNP authority to the potential of this site for the enhancement of nature-based recreational activity in the lower Adur Valley. We believe there is an opportunity here to develop a large site for quiet nature-based recreational activity which would be an appropriate use, both from the perspective of minimizing disturbance to important breeding species, and in the context of the ambitions for ecological regeneration and rewilding that are implicit in the Adur Regeneration Project.

Created August 2nd 2022

I realise this is too late for the consultation, however my suggestion would be to dam up the open end that faces the old works and puddle the entire bowl creating an enormous above river level surface water reservoir. Having worked for a water company, I am aware that despite naturally occurring aquifers, West Sussex is desperately short of supply reserves. With its proximity to the Arun River and Sussex Pad flood plain this would also aid pumping into it as well as possible overflow discharge to the river. This suggestion would I believe, have the advantages of setting up a water sports venue at Down's level coupled with the obvious height to create a potential use as a kinetic battery...a mini "electric mountain" as it were, such as used in North Wales etc. A brand-new nature reserves which would not only contribute to a growing population with a dwindling water supply that also doubles as an emergency battery for off peak/wind generated electricity storage and provides an aquatics nature reserve. ...win win win. A tourist attraction with a truly negative carbon footprint. Lack of water really is not going to be a one in fifty years event.

Focussing on the social history of lime production, kilns and vernacular buildings making use of lime and concrete historically and more recently in this area. During this time I took part in training with SPAB in grinding and mixing various lime mixes and using them to repair various local buildings. I raised the idea that the cement works would be a wonderful setting for a much needed building and historic heritage skills academy. With an education provision onsite and an outreach programme. They were interested in supporting this idea as partners. Amberley Museum and Heritage Centre were also keen on partnering to any Lime or Cement based education project as they also have historic Lime Kilns and a strong history linked with the Cement works, river barges and ways of transporting lime and other materials. I have always felt that there could be a wonderful opportunity to make use of this iconic site which I find rather beautiful in the same way that some of the previously 'ugly' or brutalist architecture is now considered to be of huge value. If an opportunity to be part of this project came about where I could take part as a volunteer or within an upcoming role I would be very keen to contribute. In my recent previous role locally I worked on a project called 'Growing Communities' with The Conservation Volunteers and Adur and Worthing Council. This project had huge potential but was curtailed in many ways by the pandemic. I feel that there is potential to create a new Community Project that brings in the same values of Sustainability and Wellbeing based at the new site to support whatever plan is chosen to take it forward. I wish you the best of luck with the Consultation and the future of the site.

I am responding on behalf of the British Horse Society, the UK's largest equestrian charity representing the country's 3 million equestrians. As with many areas in the country, and especially the south east, busy main roads have rendered connectivity of public rights of way to either side impossible. This particular area is no exception to this issue. Within the local area, there are just over 1700 passported horses contributing in the region of £10 million to the economy per annum, much of it local. Furthermore, the two National Trails in close proximity to the site means there are likely to be many more equestrians wanting to use these from further afield, either for days out or as part of a long distance ride or as a riding holiday to the area. Currently, however, non motorised users (NMUs) must use an at grade crossing point north of the Quarry site (bridleway 3209 – South Downs Way) which is a very dangerous crossing and has long been the subject of requests for a signalised crossing. We believe the solution to crossing this road safely for NMUs would be to make use of the underpass running under the A283 (Shoreham Road), linking the riverside area on the western side of the road to the Cement Works on the eastern side. As this underpass was designed to be big enough for use by vehicular traffic, we believe the opportunity should be taken to use and restrict this underpass to NMUs and to create a link to the Downs Link on the western side with the South Downs Way on the eastern side for all users. The British Horse Society would be very willing to work with SDNPA and the developers to ensure the best outcome for NMUs.
