Development of this site to include employment uses, as part of a mixed scheme in line with the SDNPA Local Plan, the Upper Beeding NDP and historic HDC aspirations, is welcomed. The different scenarios, and different levels of employment floorspace provision, which have been tested through the transport study to identify the impact on traffic movements, noise and safety, are noted.

I have worked at the cement works for most businesses started moving on to the site from 2002. Southern Transit operates 8 home to school services for WSCC, 24 hour Southern Railway replacement services, and general operational support to Go-Ahead London, schools and businesses between Sussex and London. We employ 15 drivers and 4 engineers. The cement works site is becoming increasingly popular with commercial

vehicle operators due to the alarming rate of the loss of commercial sites in the local area. For instance, Shoreham has reduced 4 brownfield sites adjacent to Adur in the last four years all the tenants have moved to the cement works. The cement works has no operating hours regulations, which being in a rural location, avoids residential complaints, which of course are difficult to avoid when operating lorries and buses which are governed by driving hours regulations that in essence take priority, so drivers need to be able to access their operating base at all times to remain within the law when working for 'around the clock' businesses. Many of Southern Transit services are out of hours, so vehicles are often accessing the site during the night. The proximity to the A27 and A24 is a huge advantage to avoid traffic congestion around Worthing.

5.0) New employment use: (Question 25: Do you think green tech companies should be encouraged to locate here?) 5.1)We welcome the statement in 5.1.8 of the AAP that: 'In summary, it has long been recognised that Shoreham Cement Works could deliver a significant quantum of new employment land and jobs centred on a greener economy. It is difficult to estimate how much land or how many jobs could be provided and it is one of the purposes of this AAP is to address this issue.' Because of its relative remoteness from residential areas and the enclosed bowl form site B, the Cement Works, seems to offer ideal opportunity for industrial /commercial use. 5.2) Section 5.11 in the AAP says that there are 'a number of options arising from the viability evidence: -A 100% private market scheme to maximise viability -A mixed tenure development with a small proportion of onsite affordable homes -Development required to provide a financial contribution in-lieu of providing onsite affordable housing -Employment uses promoted to maximise viability (B2 general industrial and/or B8 storage and distribution)' Concentrating on future B2 and B8 use has significant advantages on a site which is remote from populated areas and relatively enclosed and the Cement Works site, unsurprisingly, is ideally suited to those uses. Residential use raises issues of accessibility and sustainability and could easily result in an inappropriate, car-dependant development. Employment use, perhaps with a few live-work units, could meet the aspiration to create a greentech hub. We suggest that a fourth scenario concentrating on employment use be considered alongside the other options. It would still allow public access for informal recreational use to Riverside, the Bowl and the Moonscape.
