Title of Report Annual review of the Sustainable Communities Fund (SCF)

Note

Recommendation: The Committee is recommended to:

1. Note the year-end position of the Sustainable Communities Fund

I. Background and Summary

- 1.1 The SCF is a rolling fund established to provide grants to community and voluntary groups, social enterprise organisations and businesses for 'not for profit' projects. Projects should take place within the National Park or within 5km of the boundary where there are strong links to Partnership Management Plan outcomes. To ensure proper scrutiny and well-informed decision making an advisory panel, chaired by an SDNPA Member, advises on bids for funding between £2,000 £10,000. SCF South Downs (southdownstrust.org.uk)
- In 2018 the national Park Authority agreed to transfer the Sustainable Communities Fund balance to the South Downs National Park Trust who fundraised to match the amount. This was successful and £331,390 was invested in an endowment fund overseen by the Trust Investment panel. Both the Authority and the Trust are recognised as founding patrons of the fund in perpetuity.
- 1.3 The return from the endowment is used to run the annual grants programme whilst the remainder, alongside additional funds raised by the Trust, is invested so that the endowment can grow.
- 1.4 The Endowment therefore now stands at £431,727. This is in line with the aspirations presented to the Park Authority at the creation of the endowment and included within the associated "Funding Agreement".
- 1.5 The Sustainable Communities Fund refresh mentioned last year is ongoing, with the aim to streamline and optimise the application and funding process. A re-launch later this year can be promoted through staff and external communications to generate interest in the grant fund.
- 1.6 Two Panel Meetings were held for large grants over £2000 in 22/23 and three small grant rounds took place throughout the year.
- 1.7 The fund has allocated an annual budget to the fund of £35,000. Underspends continue to be invested alongside additional funds raised by the Trust. Should significant high-quality projects come forward the Trust may consider increasing the annual budget to support these.

2. 2022-23 Grant Giving

2.1 The SCF has committed £51,402 to eight new projects across the National Park and the surrounding boundary which includes smaller grants under £2,000. The projects are listed with a brief description in Appendix I along with a map showing the allocations and second map showing all allocations throughout the life of the fund.

I. Sustainable Communities Fund 2022-2023 Grant Allocations

1.1 <u>Trees and Beed – Petersfield Tree Team, Petersfield, Hampshire - £9,500 grant towards total project cost of £38,466</u>

Organisation: Future Shoots CIC

The Trees and Bees Project will support the successful establishment and care of trees and pollinator plots in Petersfield and the surrounding area through volunteer involvement in community social action.

1.2 Renovating one of the UKs most important rare bat roosts – Lodsworth, West Sussex - £10,000 grant towards total project cost of £220,415

Organisation: Sussex Bat Group

Phase two of a three Phase project to restore Greater Horseshoe bats to the South Downs and beyond; providing optimum conditions for this native species absent locally for 100 years.

1.3 Church Field – Greatham, Hampshire – £1,030 grant towards total project cost of £7,056

Organisation: St John's Trust

Purchase of a Shepherd's Hut as the base for our community environmental project in our field in Greatham. Purchase of gates to improve the accessibility and security for the project

1.4 The Jubilee Tap – Selborne, Hampshire - £2,000 grant towards total project cost of £9,984

Organisation: Gilbert White and The Oates Collections

To create a Tap Room at the disused former Queens Hotel in Selborne to sell beers brewed by volunteers in Gilbert White's Brewery on draught.

1.5 The Lost Railway — Steyning, West Sussex - £6,904 grant towards total project cost of £13,808

Organisation: Steyning and District Community Partnership

Design, produce and erect four educational presentation boards depicting the history of Steyning & Bramber Railway stations plus the overall history of the now defuncted Steyning Line Railway – including QR codes to link to walks and sustainable transport.

1.6 <u>Petersfield Community Garden Shelter – Petersfield, Hampshire - £10,000 grant towards total project cost of £25,171</u>

Organisation: Petersfield Community Garden

Creating a large round eco shelter within the community garden making this unique space more flexible for all current and future users. A shelter giving encouragement to be outside.

1.7 <u>Lewes High Street – traffic reduction, greener streets travel pilot – Lewes, East Sussex - £8,000 grant towards total project cost of £31,000</u>

Organisation: Cycle Lewes

The pilot project aims to reduce carbon emissions and mitigate climate change whilst boosting town centre vitality by removing traffic, increasing active travel options and re-imagining a pedestrian-friendly town.


1.8 Benfield Hill Local Nature Reserve – 30th Anniversary – Hove, East Sussex - £3,968 grant towards total project cost of £9,333

Organisation: Benfield Wildlife and Conversation Group

Installation of two interpretation/information boards showing the walking trails and what to see during the year. Celebrations commemorating that Benfield Hill was designated as a LNR in 1993.
