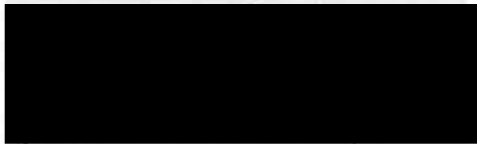
Declaration

- d) participate in any discussion or vote on the matter in which I have a disclosable pecuniary interest (unless I have received a dispensation in accordance with the Localism Act 2011).

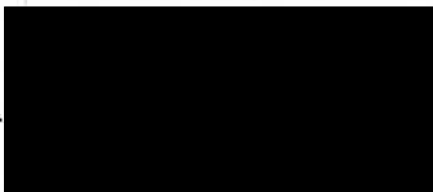
