TOWN & COUNTRY PLANNING GENERAL DEVELOPMENT ORDER, 1950
AS AMENDED BY THE TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT
(AMENDMENT) ORDER, 1958 AND THE TOWN AND COUNTRY PLANNING
GENERAL DEVELOPMENT (AMENDMENT) ORDER, 1960.

Article 10

W H E R E A S the Council of the Borough of Hove acting for and on behalf of the East Sussex County Council the Local Planning Authority for the Borough of Hove are satisfied that it is expedient that the development of the description set out in the Schedule hereto should not be carried out on certain land within the Borough of Hove namely:-

the land shown coloured pink on the map annexed hereto comprising land on the south-west side of Devils Dyke Road and immediately south of the Hove Borough Boundary forming parts of Ordnance Survey parcels 9 and 11 Sussex (East) Sheets Nos. L11.15 and L11.16 and also smallholding forming parts of Ordnance Survey parcels 5c, 5d and 5e Sussex (East) Sheet No. L11.16 (1931 Edition Scale $\frac{1}{2500}$) known as Golf Farm

unless permission therefor is granted on an application in that behalf made under the Town and Country Planning Act, 1947 and the Town and Country Planning General Development Order, 1950 as amended by the Town and Country Planning General Development (Amendment) Order, 1958 and the Town and Country Planning General Development (Amendment) Order, 1960

N O W T H E R E F O R E the said Borough Council acting for and on behalf of the East Sussex County Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order, 1950 as amended by the Town and Country Planning General Development (Amendment) Order, 1958 and the Town and Country Planning General Development (Amendment) Order, 1960 HEREBY DIRECT that the permission granted by Article 3 of the said Order shall not apply to development of the said land of the description set out in the Schedule hereto.

This Direction may be cited as the Town and Country Planning (Borough of Hove) (Golf Farm) Direction, 1961.

SCHEDULE

Development consisting of the erection of barns and buildings for the storage of animal feeding stuffs, being development comprised within paragraph (1) of Class VI of the First Schedule to the Town and Country Planning General Development Order, 1950, namely:-
The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture, other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings.

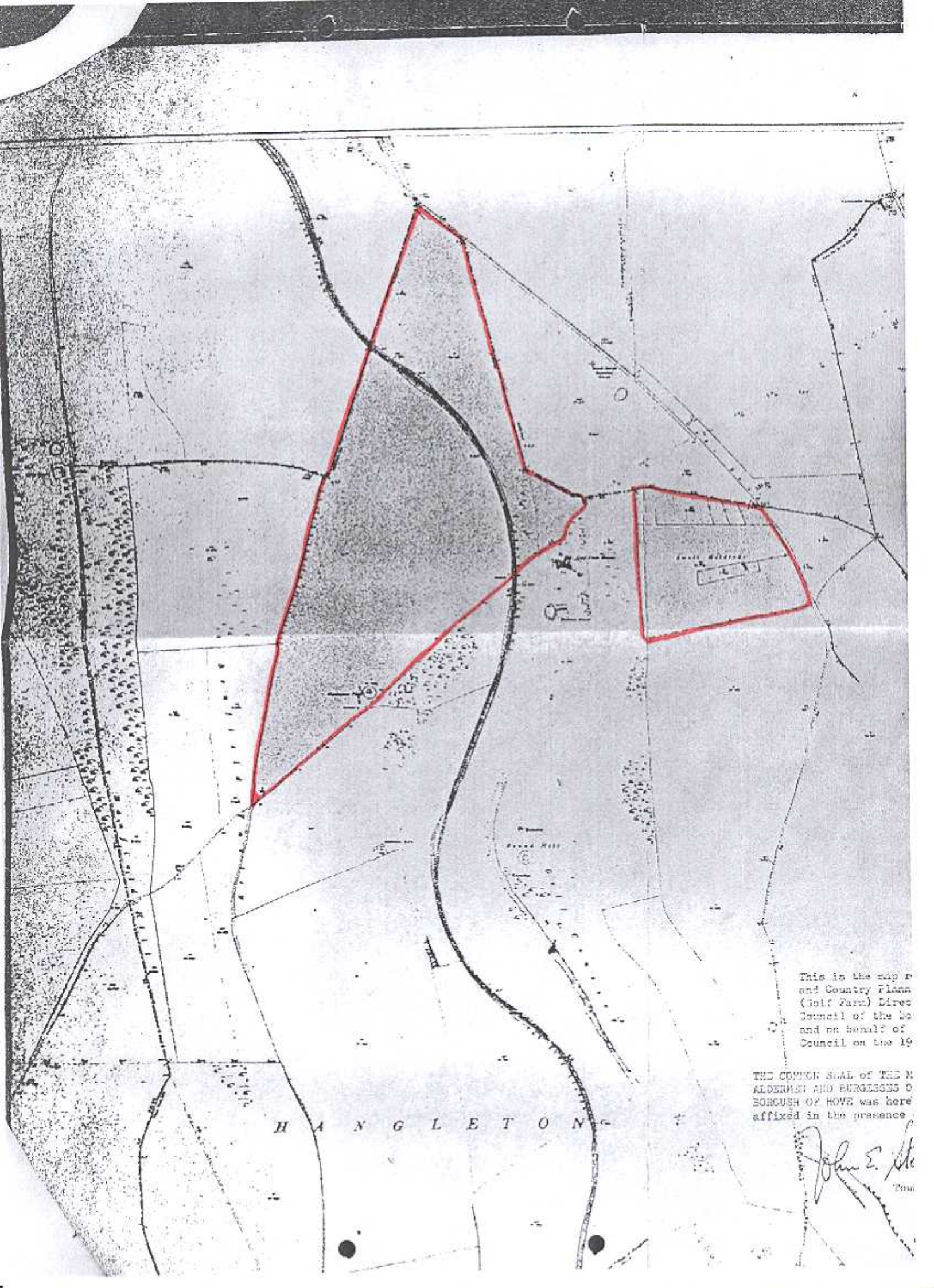
