3. **THE RELEVANT PLANNING PERMISSION**

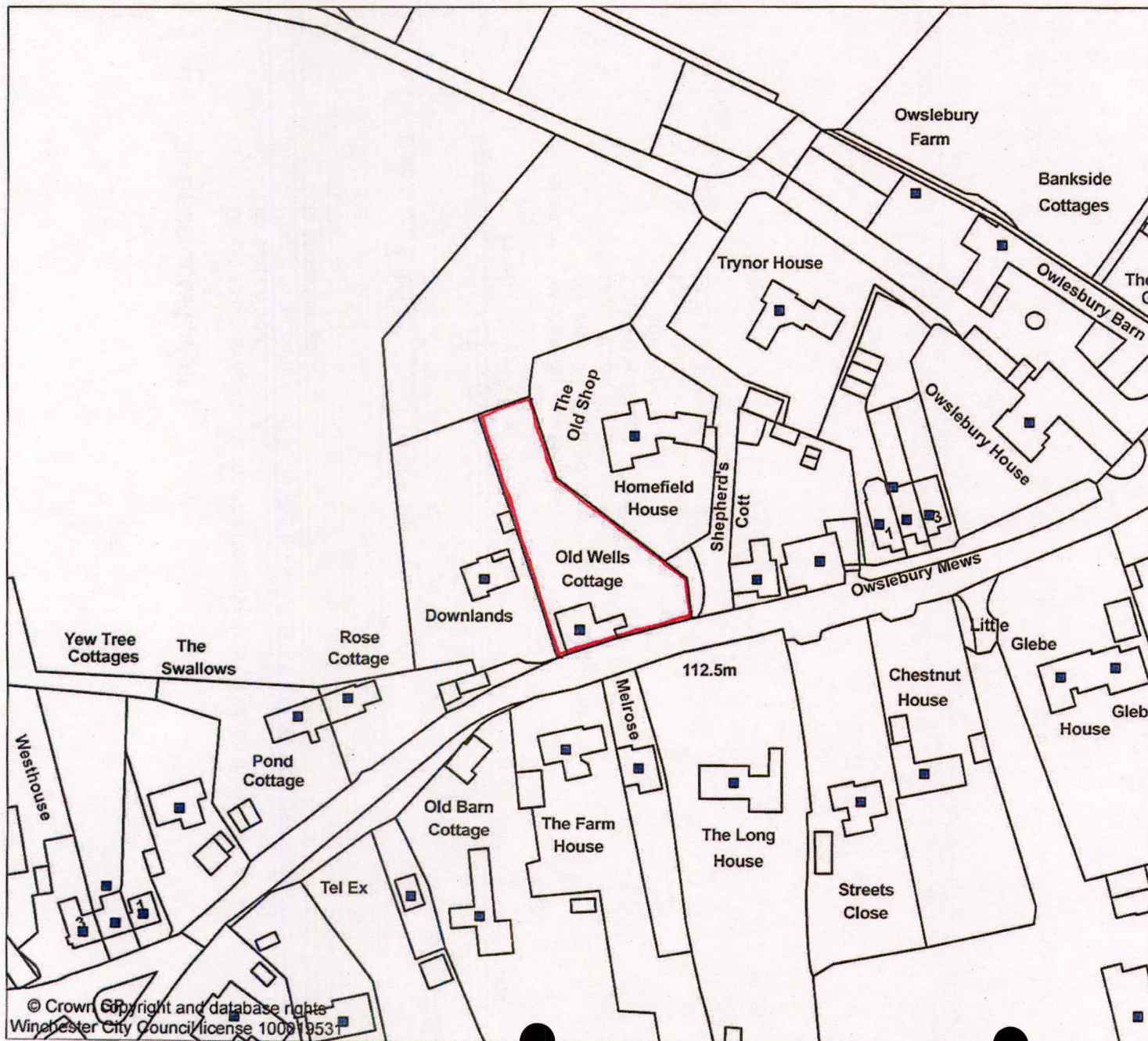
The relevant planning permission to which this notice relates is the permission granted by the Local Planning Authority on 12th September 2013 for the construction of an attached double garage and the creation of a new vehicular access, reference: SDNP/13/03664/HOUS.

The following condition has not been complied with:-
 - (2) The materials to be used in the construction of the development hereby permitted shall be those as detailed in the materials section of the accompanying application forms and as annotated on the approved drawing 107 Rev. D
5. **WHAT YOU ARE REQUIRED TO DO**

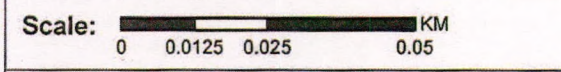
As the person responsible for the breach of the condition specified in paragraph 4 of this notice, you are required to comply or secure compliance with the stated condition by taking the following steps:-
 - (i) Remove all bold roll, interlocking, terracotta coloured roof tiles from the double garage (including the linking passage), hatched blue on the attached plan.
 - (ii) Fit clay tiles which match the existing clay tiles on the porch roof.
