Title of Report Appointment of Committees

Decision

Recommendation: The Authority is recommended to:

- I. Agree the appointment of Vicki Wells to the Policy and Resources Committee until the Authority AGM in 2024 as set out at Appendix I of this report;
- 2. Agree the appointment of Antonia Cox to the Planning Committee until the Authority AGM in 2024 as set out at Appendix I of this report; and,
- 3. Note the election of Steven Ridgeon as co-Deputy Chair of the Policy and Resources Committee, alongside Maggie Jones who was appointed at the AGM.

I. Introduction

- 1.1 At its AGM in July 2023 the Authority agreed its annual review of arrangements for discharging its decision-making responsibilities, in particular the delegation of responsibilities, and making of appointments, to Committees. Further to the committee member appointments made at that meeting, there remained two vacancies on the Policy and Resources Committee as SDNPA Members had not at that point been appointed by the Defra Secretary of State or by Worthing Borough Council. In addition, at the AGM, only one of the two Deputy Chairs of the Policy and Resources (P&R) Committee were appointed and it was explained that, in accordance with Standing Order 8.3, that the duty to elect a further Deputy Chair would fall to the P&R Committee.
- 1.2 Under Schedule 7 Para 13(3) of the Environment Act 1995, the Authority has a duty to secure that the division of local authority appointed Members and Secretary of State appointed Members on any Committee is (as nearly as possible using whole numbers) in the same proportion as required in the case of the Authority itself and this has been borne in mind when allocating Members to committees.

2. Issues for consideration

- 2.1 In summary the proposed amendments to the membership of committees which are recommended for approval by the Authority are:
 - Appoint Vicki Wells to the Policy and Resources Committee.
 - Appoint Antonia Cox to the Planning Committee.
- 2.2 This change would increase the number of Members on the Planning Committee to 13 and reduce the number of Members on the Policy & Resources Committee to 11. In both cases the division of Local Authority and Secretary of State appointed Members would reflect, as near as possible, the same proportion as the Authority.

2.3 Members are also invited to note the election of Steven Ridgeon as co-Deputy Chair of the Policy and Resources Committee at the meeting of the committee on 21 September 2023. Steven will work as co-Deputy Chair alongside Maggie Jones, who was appointed at the Authority AGM on 11 July 2023.

3. Options & cost implications

- 3.1 The Authority could decide not to make the proposed appointments to committees. However, the proposed committee appointments are in line with the Authority's approach that all Members be appointed to a committee of the Authority save for a small number of Members who are not appointed to committees in order to undertake, within the parameters of the Member role description, other roles to support the work of the Authority.
- 3.2 The costs associated with the administration of the decision-making structures of the Authority are met from within the Authority's core budget.

4. Next steps

4.1 Should the appointments be approved, officers will take the necessary administrative steps to effect the change.
