## The vision for the future...

What are the three key changes you would like to see in your Parish over the next 15 years? These changes should relate to the priorities set out below. It will also be helpful to explain when you think these changes should happen over the 15 year period.

<p><b>Development – accepting some development to take place but in consultation with the parish council. Any development should be limited to small affordable housing to meet the needs of existing residents. Development <b>MUST</b> be sensitive to the area and within the current settlement boundary. All new build development and refurbishment of existing properties to incorporate measures to mitigate climate change eg; solar panels, Air Source heat pumps and greywater reuse and be constructed to perform beyond current building regulations (eg Passivhaus standards).</b></p> <p><b>Traffic Management – To make the village a safer environment for pedestrians and cyclists reduce both the volume and speed of traffic on the C324 through the village; reducing its use as a 'rat-run' Increase enforcement of the current traffic restrictions and thereby reduce the number of large overweight vehicles currently passing through the village flouting the restrictions. (NB KPC is currently working up a proposal to improve traffic management.)</b></p> <p><b>Green space – To protect the public green spaces from built development: ensure they are managed for the benefit of all the community enhancing bio-diversity and nature recovery together with playing of sports and games. Privately owned green spaces should be protected from development if it adversely impacts the characteristics of the village and surrounding landscape. Encouragement should be given for the land to be managed to enhance bio-diversity and support nature recovery.</b></p>

<p><i>Active travel priorities, roads / parking, community buildings needs, waste / water infrastructure, broadband, renewable energy</i></p>	<ul style="list-style-type: none"> <li>• A lack of frequent public transport options. We would like to see more regular bus services.</li> <li>• Broadband connection can be slow.</li> <li>• Domestic solar installation should be encouraged.</li> <li>• Cycle paths and footpaths should be maintained regularly, and the network improved and extended to allow greater connection to Lewes (C7) and Brighton (A27) and the South Downs Way National Trail network and other routes.</li> <li>• Surface water flooding should be addressed.</li> <li>• Traffic volume and speed through the village needs to be addressed and mitigated to improve road safety for non-motorists.</li> <li>• To ensure the future viability of the village school</li> </ul>
