



## Upham Village Design Statement

**NOTICE IS HEREBY GIVEN** that Upham Parish Council (UPC) has submitted the Draft Upham Village Design Statement (UVDS) to the South Downs National Park Authority (SDNPA) to be adopted as a Supplementary Planning Document (SPD).

The Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended), and the South Downs Statement of Community Involvement, require the South Downs National Park Authority (SDNPA) to carry out a minimum of 8 weeks' public consultation, inviting comments from any interested party on the Upham Village Design Statement (UVDS).
